Message from the Executive Director

Dear clients, partners, and friends of the CFDC,

On behalf of the team of the CFDC, I thank you for all your support as we ring in our 30th year!

Thirty years of supporting the community and small business in the Region and we have accomplished so much together with our partners and volunteers and with the support of our main funder FedDev.

It is no secret that Canadians do not like to brag, but brag we must as we have much to be proud of. This past year we not only hit every target, but exceeded them all. We saw some of the highest levels of referrals from our clients and key partners yet. We more than doubled our target for dollars lent and achieved four times our target for dollars leveraged. This is due to our strong partnership with other lending institutions like the Business Development Bank of Canada (BDC) and Chartered Banks. We are dedicated to providing our clients with the best funding options. Our trusted partnerships with these institutions allows us to do this.

We now have a well balanced portfolio and are always ensuring we take the appropriate amount of risk for our small businesses. In fact, while we lent out more dollars, our portfolio risk rating decreased. We are making smart investments that support the growth of small business while ensuring a reasonable return on investment so that our pool of funds continues to grow ensuring more entrepreneurs can be supported.

Our team has been touted as instrumental in the launch of the Cornwall Innovation Centre and we continue to look for more ways to support the growing innovation ecosystem at the NAV CENTRE, St. Lawrence College and the River Institute. At the end of the year we launched the Cross-Border Partnership Program which seeks to strengthen ties between Akwesasne and the surrounding municipalities. Initial feedback on the program has been phenomenal and we are eager to push the project forward in 17/18 with the understanding that we are "stronger together". Aligned with that mantra, the Regional Economic Renewal Summit was organized in partnership with the Ontario Chamber of Commerce and other key local partners. This event resulted in several working groups whose members continue to push for positive change in the Region in 17/18. Building a stronger more self-sufficient and cooperative Region continues to be a cornerstone of the CFDC mandate.

We are now doing all of this out of our central location at Commerce Court. Moving downtown this past fall to co-locate with the Cornwall & Area Chamber of Commerce, the Business Development Bank of Canada, and Heart of the City has been a real positive change and has allowed for more collaboration and positive impact for our clients.

None of this would be possible without a dedicated, passionate and incredible hard working team. The CFDC team have done whatever it takes to get the job done and always keep the

client and our partners front of mind. With such a small team we are able to accomplish so much because we work together so fluidly and respect one another totally. The CFDC Framework

Created in 1987, the Cornwall & The Counties Community Futures Development Corporation (CFDC) is a not-for-profit organization focusing on:

- > Strategic community planning and socio-economic development;
- Support for community-based projects;
- Business information and planning services; and,
- Access to capital for small and medium-sized businesses and social enterprises.

Mission:

Cornwall & The Counties Community Futures Development Corporation is a catalyst, a leader, and a partner for a sustainable and growing economy that builds on the assets that Akwesasne, Cornwall and SD&G has to offer.

Vision:

As the result of stakeholder consultation, through which valuable insight was solicited, the Board of Directors of the CFDC has elaborated overarching goals (Ends) to be achieved on behalf of its constituent (The Community of SD&G).

The *Ends* statement posits that:

1.0 Akwesasne, Cornwall and the SD&G Counties is a well-connected, innovative, unique, inclusive, and thriving community of choice.

To be achieved at a sustainable level of cost-efficiency, *Ends* attributes comprise of:

- 1.1 Clients and partners understand this community, achieve their goals, and create and maintain sustainable jobs with the community.
- 1.2 Clients and partners attract and retain young people.
- 1.3 Clients and partners recognize and value education, training, and growth potential of their employees.
- 1.4 Everyone can connect from anywhere in the community to regional, national and global networks.
- 1.5 Clients and partners work together to grow and innovate new industries for healthy living.

Investment Fund Activity - Lending

The purpose of the investment fund is to provide repayable financial assistance in the form of loans to small and medium-sized businesses and social enterprises. Typically available to those experiencing difficulty in securing tradition bank financing, eligibility for CFDC borrowing is essentially confined to activity relating to the creation, development, stabilization, expansion or restructuring of business operations.

Subject to a structured examination of information and documentation requested of a client, the CFDC will favour funding applications which:

- Promote the creation and/or retention of jobs and opportunities;
- ➤ Demonstrate that the CFDC's involvement will lead to economic benefits or net gain within the community;
- Attract capital investment to the community;
- Afford the prospect of involving multiple funding partners (granting and lending) towards effective leveraging and optimization; and,
- > Reveal a reasonable expectation of profitability and debt servicing capacity.

Importantly, all applications made to the Cornwall & The Counties CFDC are considered and vetted by the Investment Committee, which is a duly authorized, and Board appointed panel of independent community peers having business and executive experience. Its powers are granted through by-law provision as may be from time to time revised by the CFDC's Board of Directors.

As an impartial panel, the Investment Committee sets investment policy, reviews investment practices, and authorizes financing decisions – ensuring also to maintain exchange with the Board of Directors. Moreover, all Directors of the Board are welcome to attend and to participate in meetings of the Investment Committee which at minimum, reviews monthly the Portfolio Loan and Cash Balance Summary, Security Evaluation Updates, pending Loan Applications, Delinquency Report, and Updates and such other matters as may be required for the effective stewardship of the loan portfolio.

Taken with the EODP and the CFDC's business counselling and referral services, the Cornwall & The Counties CFDC is well poised to assist clients with their financing needs and to structure multi-party financing when the circumstances warrant or the interests of the client are better served.

The Cornwall & The Counties CFDC has seen many business ideas come to fruition through responsible lending to local businesses. One great example amongst the many comes in the form of an investment fund loan made to "Kenda Bathware Inc. located in Long Sault, ON.

One of our 2016/2017 Success Stories

Kenda Bathware Inc. is a new company founded in December 2014 with 25 years of experience in the acrylic manufacturing business through its owner. In addition to this, Kenda Bathware Inc. has secured the services of a Sales and Marketing Director with 15 years of experience in the finished plumbing sector on a national level.

The current market size and the recent changes by key competitors has opened up significant opportunity for a "new face" within the acrylic manufacturing industry. A key competitor, American Standard has closed both of its manufacturing facilities in Cornwall, ON and Winnipeg, MB in favor of its American factories. This exit and the rising American dollar has provided an industry gap, thus the creation of Kenda Bathware Inc.

A partnership between the BDC and CFDC Investment Fund allowed the company to secure financing and funding support to assist with the cost of equipment, inventory and some working capital. There was also an EODP investment to assist with the cost of renovations and equipment purchases. Desjardins provided the initial financing and Launch Lab services were provided to guide them in their marketing and sales strategy as well as future opportunities to diversify their market share.

Within the next few months they hope to hire 2 new full time manufacturing positions and over 12 new full time employees at the end of year 5.

Local jobs, local contractors and local suppliers will see an impact as a result of this new manufacturing facility. With the closure of other warehouse and logistics companies, it is promising to see new manufacturing facilities open/set-up in the Cornwall and SDG area. Local support from the CFDC and other partnering agencies will contribute to the success of this new company.

The Eastern Ontario Development Program (EODP)

The Eastern Ontario Development Program is a Government of Canada initiative supported by the Federal Economic Development Agency for Southern Ontario. It seeks to enhance and help diversify local economies and leads to the growth of new and existing businesses within rural Eastern Ontario communities. Over the next five years (2014-2019) 2.25 million dollars will be invested in local businesses in SD &G through the EODP.

In 2016-2017, the Cornwall & The Counties CFDC received and reviewed 35 applications.

There are two streams of the Eastern Ontario Development Program.

First is the Business Development Stream. The objective of the EODP Business Development Stream is to support projects that will lead to the growth of new and existing businesses within rural Eastern Ontario communities. This includes initiatives in key areas such as skills development, youth attraction, innovation and adaption of information and communications technologies.

The second stream of the Eastern Ontario Development program is the Community Innovation Stream. The objective of the EODP Community Innovation Stream builds the economic and innovative capacity of rural eastern Ontario communities, and develops opportunities for sustainable economic growth and employment. This Stream is ideal for applicants who work in partnership with community stakeholders and must have a minimum of two contributing partners.

The Cornwall & The Counties CFDC has witnessed significant success of the EODP (grant program). One such example is represented through "Fauxmagerie Zengarry Cashew Cheese Inc." outlined below.

One of our 2016/2017 Success Stories

Fauxmagerie Zengarry was founded in 2013, in a certified home based kitchen by the owner, Lynda Turner. By the end of 2013 Zengarry's cashew cheeses were available in 8 stores in 4 cities across Ontario and Quebec. Currently Fauxmagerie Zengarry is the most widely distributed Canadian non-dairy fine cashew based cheese.

The business began growing rapidly and needed to relocate from their certified home kitchen to a rental facility on Main Street in Alexandria. The new commercial facility provided the space required to increase production in the upcoming years, and allow room for expansion over the next 5 years.

The project also included hiring new production staff and a kitchen manager and launch a new marketing strategy, which included new packaging, participation in health related trade shows and vegetarian and vegan festivals across Canada, targeted online advertising initiatives, etc.

The funds from the Eastern Ontario Development Program assisted with the cost related to renovations and new equipment for the new space as well as salaries for new hires. A total contribution of \$27,000 has allowed the company to increase their production and meet new demands and to gradually grow into larger grocery chains. This will establish Fauxmagerie Zengarry as the premier cashew cheese producer in Canada and result in a significant increase in revenues. One of the main priorities of the Expansion project is to allow the owner to shift her focus to business management, sales and marketing and product development and away from day to day production tasks. This project created 4 new jobs.

Supplementing the CFDC's routine awareness campaign, the CFDC working with local elected officials, will on occasion issue news release as that reproduced below, hosting also community events and announcements in partnership with community leaders.

North Glengarry Businesses "Fauxmagerie Zengarry" and "Cedar Ridge Designs" Receive Eastern Ontario Development Program Support

October 14th, 2016 Alexandria

Fauxmagerie Zengarry and Cedar Ridge Design will benefit from an investment announced today by The Cornwall & the Counties Community Futures Development Corporation (Cornwall & the Counties CFDC) and Francis Drouin, Member of Parliament for Glengarry-Prescott-Russell.

Fauxmagerie Zengarry will receive an investment of up to \$22,000 under the Eastern Ontario Development Program's Business Development stream for its business expansion project. The funding will support the relocation to a facility on Main Street, resulting in an increase in production, employment of new staff and the ability to respond to increased demand, which will benefit Alexandria and the surrounding region.

Cedar Ridge Designs will receive an investment of up to \$25,000 under the Eastern Ontario Development Program's Business Development stream for its manufacturing expansion project. The funding will support the expansion of the manufacturing facility, and the development and implementation of a Smart Technology based production process. The project will increase sales, streamline processes, and benefit Maxville and the surrounding area.

The Eastern Ontario Development Program (EODP) advances economic development in rural eastern Ontario. Through EODP, the Federal Economic Development Agency for Southern Ontario (FedDev Ontario) is collaborating with Community Futures Development Corporations (CFDCs) in eastern Ontario to promote the growth of new and existing businesses in rural communities.

- Fauxmagerie Zengarry produces dairy free cheese from cashew nuts. The company was founded in 2013 and is located in Alexandria.
- Cedar Ridge Designs specializes in custom cabinetry and woodworking for residential homes, and commercial spaces throughout Eastern Ontario.
- The Cornwall & the Counties CFDC is one of the 15 Community Futures Development
 Corporations (CFDCs) in eastern Ontario funded through FedDev Ontario's EODP the .
 CFDCs deliver a wide variety of programs and services to support community economic

 a volunteer board of directors made up of local residents representing the community.

The High School Entrepreneurial Outreach Initiative

The project reached a total of 469 youths from 13 different high schools and 3 local not for profit organizations in Cornwall, Stormont, Dundas, and Glengarry Counties.

Students were offered a chance to listen, converse, explore, and be inspired by local entrepreneurs. Since starting and owning a business is often overlooked or undervalued by high school students, our events were designed to present entrepreneurship as an attractive and attainable career option to those who might otherwise never consider it.

The Be the Boss Day programs offered a chance for students to explore what it would be like to own their own business or operate a farm. Results from our program evaluations show that the majority of students who participated in the Be the Boss day events said they learned something new about running a business and would like to start their own business in the future.

The most celebrated success stories from this project relate to youth employment by their host business following their Be the Boss placement. We know that 13 youths were hired by their hosts for summer placements.

Many thanks to our local businesses owners who generously provided their time and support towards this initiative.

Cross Border Partnership Program

The Cross Border Partnership Program is dedicated to building stronger relationships between Akwesasne and the municipalities that surround it.

What are the Objectives/Future benefits

- 1. A stronger unified voice for engaging with business and other levels of government.
- 2. Stronger regional identity, relationships and sense of place.
- 3. Cost savings when providing services due to higher efficiencies and less duplication.
- 4. More opportunities for local business development and jobs.
- 5. Ability to leverage the unique financial, human and physical capabilities of each partner
- 6. Coordinated planning efforts to improve land use and land management (making room for growing populations and to attract new investors and citizens.)
- 7. Coordinated planning efforts to aid in protecting resources and natural environments that are important to partner communities.
- 8. A stronger knowledge of our communities through a coordinated educational effort and through community workshops.
