Report Builder in Action

Report on What's Important to You

Population health priorities vary from organization to organization, along with time and team resources. Is your focus on lowering overall Rx spend? Or are you monitoring a cohort's care adherence after implementing a new copay? No matter your current priorities or bandwidth, **Springbuk Standard Reports equip you with out-of-the-box, ready-to-use reports, across five different categories, including:**

Financial: Overview of previous, current, and forecasted plan spend highlighting plan performance compared to budget.

Forecast Change Report: Understand metrics and changes after a monthly update and pinpoint what drove the changes:

- › Quickly see the important changes in the forecast analysis
- › Increased transparency in forecast key drivers of change

Financials Report: Look deeper into the source of high-cost and analyze month-by-month trends:

- › Total paid by month stratified by medical and Rx
- › Key inpatient, outpatient, and Rx metrics with change from prior results
- › Top drugs based on total paid, including year over year trends

Financial Overview Report: View a high-level summary of overall financial performance to help you answer:

- › What metrics should I be focusing on?
- › What diagnoses and drugs are driving my monthly spend and cost trends?
- › How much do high-cost claimants influence overall spend?

IBNR Summary Report: Review an overall incurred-but-not-reported summary that will help you:

- › Estimate outstanding claim payment liability
- › Understand your carrier payment patterns

Utilization: Addresses utilization metrics, enrollment, and pharmacy utilization.

Utilization Overview Report: Review an overall utilization summary with details on:

- › Where your members are seeking care
- › Key utilization metrics, such as Inpatient Admits/1000, including year over year trend

Utilization - Emergency Department Report: View a high-level emergency overview, ER utilization trends, and care alternatives:

- › ER Pattern of Use
- › Non-Emergent Conditions
- › Primary Care Visit More Appropriate
- › Chronic Disease Flareup Visits

Utilization - IP Admissions Report: Look deeper into admissions and answer:

- › What are my KPI's around IP Admissions?
- › Which admissions are potentially avoidable and why?

Clinical: Analysis of percent of the population with gaps in care and compliance and prevalence across conditions. Receive expert physician explanation(s) of various metrics included in reports and understanding of their importance:

Gaps in Care Report: Provides a summary report of the gaps in care data, displaying:

- › Percentage of members with a gap in care
- › Current spend and forecasted spend for those members with a gap in care
- › Conditions by savings opportunity

COVID-19 Impact Report: Provides information related to the impact of COVID-19 on enrollment, spending, utilization, and gaps in care:

- › Trending of enrollment by month
- › Year over year trends in spending
- › Trends in gaps in care
- › Trends in drug utilization

Diabetic Care Report: Group related gaps in care, understand the potential impact of different gaps, and highlight various trends, including:

- › Treatment effectiveness
- › Diabetic drug compliance
- › Compliance related to measurement and treatment of macrovascular (large vessel) disease common in diabetics
- › Compliance with measures related to renal disease and eye disease in diabetics

Condition-Specific Reports: Provides a comprehensive analytic story of your members with a specific condition including:

- › Service Type Classifications
- › Sources of Care
- › Prescription Drug Claims
- › Clinical Risks & Insights

Pregnancy and Delivery Report: Provides an overview of pregnant members including the following:

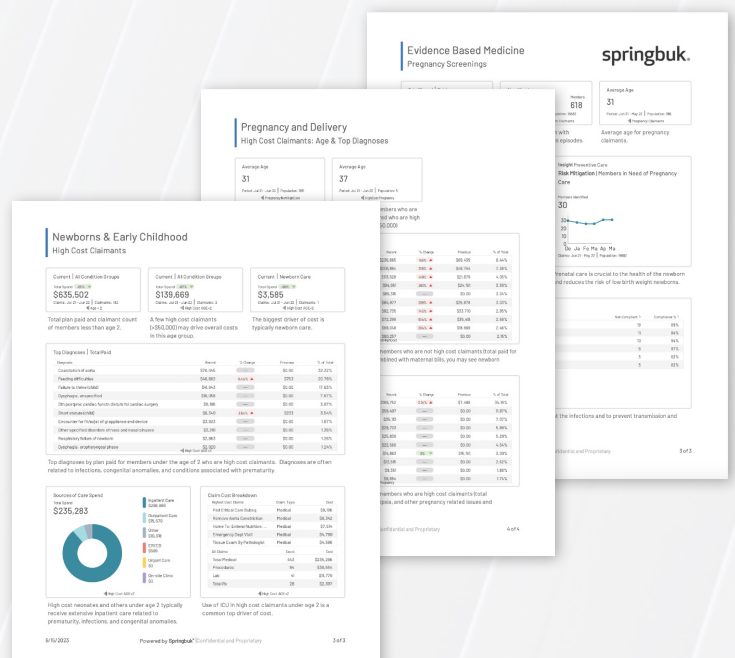
- › Demographics

- › Top conditions (Members under the Age of <2)

- › Adherence to evidence based medicine
- › High cost claimants and the associated diagnoses.

Pregnancy, Delivery, and Newborns Report: Summarizes data across pregnancy, delivery, and newborns

- › Costs, claimant counts, and trend for pregnancy/delivery newborn care episodes.
- › Adherence to evidence based medicine
- › High cost claimants and the associated diagnoses.



Drug: Identifies drug spending and savings opportunities as well as drug adherence.

Drug Utilization Report: Understand drug spending and therapeutic classes as well as specific drugs that drive it, such as:

- › Overall and per member per month (PMPM) spending on drugs
- › Top 5 therapeutic drug classes by spending and frequency
- › Top 10 drugs by total paid, average paid, and frequency

Drug Savings Opportunities Report: Analyze drug savings opportunities grouped by:

- › Information on the potential savings and trends to help identify areas with the largest opportunities
- › Number of members taking the brand name drug, which can inform strategy – for example, a more targeted approach if only a few members are taking a very costly drug

Drug Adherence Report: Group drugs used in treating specific conditions, including:

- › Explanation of the role of each drug in the condition
- › Trend information related to drug adherence to inform where to focus your efforts

Risk: Identify overall risk identification and analysis of members with chronic conditions, gaps in care, and biometric risk stratification.

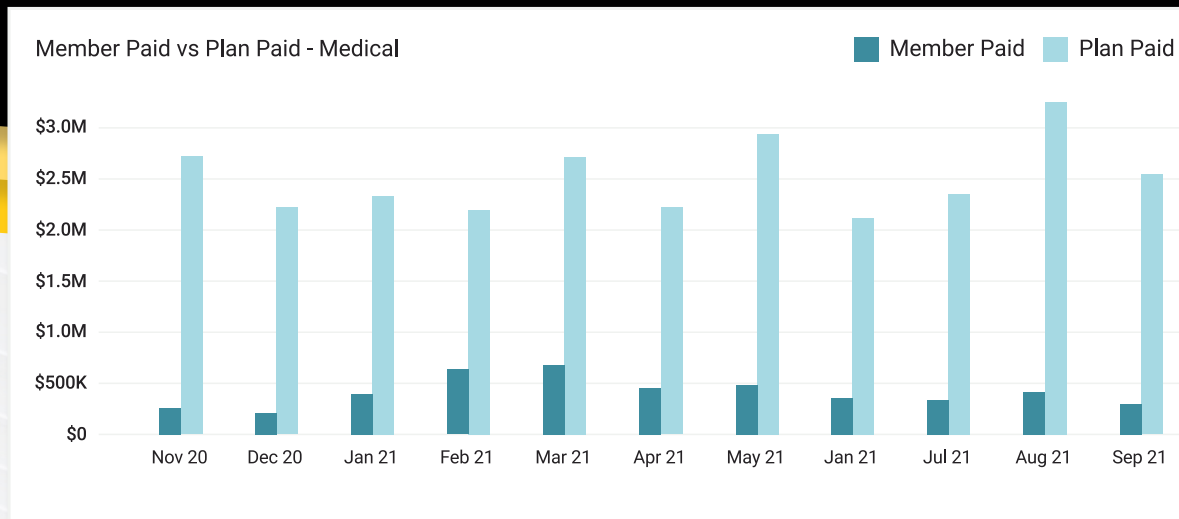
Health Status Report: Provides a snapshot of the organization's health which includes:

- › Identification of top chronic condition opportunities
- › New trends in diagnoses within your population

Clinical Risk Mitigation Report: Organize risk by members with multiple conditions that are at risk due to:

- › Having two or more chronic conditions
- › Having a chronic condition along with a mental health condition
- › Having diabetes and heart conditions
- › Having diabetes and peripheral arterial disease

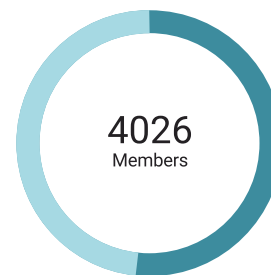
