Achieve accessible and safe drinking water and sanitation for all including the increase of water use efficiency in each development by 2030. We also aim to support community led water protection with every development.

The creation of agri-urban food production within each development, capable of feeding all residents and visitors of each of our communities

Work alongside farmers living within the existing community to increase the economic, social, and climate resilience of our agri-urban food production communities. # **Sector Specialisation**

Our focus on developing Greenfield Sites lies in the potential to create iconic wellness-based lifestyle developments that enhance the quality of life for both residents and visitors.

By seamlessly integrating ownership, short-term accommodation, and commercial leasing within one comprehensive model, we are able to offer our stakeholders a diversified portfolio with projected gross returns in excess of 80%.

Portfolio Countries are chosen based on a concise analysis of varying factors, such as:
Government stability, economic stability, international tourism potential, land value, scarcity of high-quality housing, and potential for financial returns and available Citizenship by Investment Programmes.

By 2040, approximately two-thirds of the global building stock will consist of structures that currently exist. Without proper upgrades, these buildings will continue to contribute to greenhouse gas emissions.

To address this issue, Earthland Global's Technical Building Energy Efficiency Team has been tasked with acquiring and renovating existing Greyfield Sites, transforming them into premium, 'net-zero energy' mixed-use buildings and developments.

This large-scale initiative is highly sought after by the governments of many Caribbean countries, as it not only reduces energy consumption but also provides a higher return on investment.





### How We Work





#### **Development Partner Activation:**

As a Development Partner of Earthland Global, each investor/ company commits to a designated funding target and submits a one percent activation fee to Earthland Global. In return, Earthland Global's experienced team provides the following services:

- a. A comprehensive feasibility analysis of the selected real estate model (sustainable multifamily, mixed-use, or master-planned community) is conducted and compared against the 5 Latin American countries and 11 Caribbean countries within Earthland Global's portfolio. This analysis considers the legal, economic, political, market, environmental, technical/logistical, financial, and operational aspects of the chosen real estate model in each jurisdiction.
- b. Once the feasibility analysis is completed, the Development Partner will determine the most attractive country(ies) to pursue. Earthland Global then takes the necessary steps to finalize the negotiations, concessions, and permissions for the approved property with the current owners and government entities.



#### **Land Acquisition:**

The Earthland Global Management team then takes on the responsibility of acquiring the land and obtaining all necessary development permissions within the selected country, adhering to the pre-approved pledged budget. This ensures a seamless process and allows the Development Partner to focus on the investment aspect while Earthland Global handles the planning, management and logistics of the project.



#### **Pre-Development:**

The Earthland Global Sustainable Technical and Construction Management Team is responsible for carrying out the following key stages of pre-development:

- a. Site Preparation Clearing the land, removing any existing structures, and installing necessary utilities.
- b. Sustainable Design and Planning Developing architectural plans, engineering drawings, and specifications to achieve the highest possible certifications in sustainability, such as LEED or DGNB.
- c. Permitting Obtaining all necessary zoning and environmental approvals, which will have been finalized upon Development Partner Activation. Any additional building approvals required will also be secured at this stage.
- d. Pre-Construction Planning Planning the project schedule and construction logistics, including procuring materials (including all renewable energy systems) and coordinating subcontractors.



#### **Marketing and Local Community Outreach:**

The Earthland Global Sales & Marketing Team is committed to fostering a strong relationship with the local community and keeping residents informed of project developments. Additionally, they aim to generate international interest and raise awareness among potential buyers and investors in our target markets of the Caribbean, Europe, North America, and the Middle East through the use of:

- a. Digital marketing strategies
- b. Public relations campaigns
- c. Establishing sales and leasing centers in each target market, which will focus on securing pre-orders at this stage.

#### **Construction:**
