Consent means to agree to engage in a sexual act and you must have the freedom and capacity to make your own informed decisions, and you have the right to say no at any time. No means no.

We believe that no person should suffer the experience and effects of sexual violence and harassment, and will ensure that there is dedicated specialist support, including free and accessible counselling for all individuals involved.
