Hypatia Women Hedge Fund Index^{s™}

The Hypatia Women Hedge Fund Indexsm, designed by Hypatia Capital Management LLC and created in 2020, measures the performance of investable hedge funds managed by women which meet certain rules-based criteria. Funds are selected from a universe of hedge funds compiled by Hypatia Capital Management LLC, sourced from publicly available information, industry associations and industry contacts.

Membership

To be included in the Hypatia Women Hedge Fund Index, a fund must:

- Have a female portfolio manager or Chief Investment Officer, or Chief Executive Officer who owns 50%+ of the firm
- Manage at least \$100 million in strategy AUM
- Report monthly returns in USD
- Report net of all fees returns
- Pass an annual operational due diligence review, including audited financial statements

Adjustments & Maintenance

The composition of the Hypatia Women Hedge Fund Index is reviewed quarterly: March, June, September and December. Any adjustments are made according to the following rules:

- Preliminary Index level updates will be published on the tenth business day of each month and finalized on the month end. Missing constituent returns will use the weighted average of the reporting funds.
- The composition of the eligible universe is reviewed using prior quarter end information, preannounced two months and ten business days prior to the quarter end rebalance.
- Additions include identified funds that meets all criteria for membership.
- Deletions include constituents that no longer satisfy the membership criteria, including funds who do not meet the assets under management requirement for two consecutive quarters.
- The Hypatia Index Committee may remove any fund that fails to submit monthly return updates by the required submission deadlines.
- The Hypatia Index Committee may, at its discretion, remove a constituent if it poses operational, performance or other risks whereby it deems removal necessary to protect the integrity of the index.

Weighting

Constituent weights are equal-weighted effective on the month end of March, June, September and December.
