**AUDIT EXECUTIVE SUMMARY:**

Freyco Produce is located in Decker, IN. The company grows and harvests pumpkins and watermelons. The farm in scope is the VM farm, which is approximately 65 acres. The fruits are hand harvested and sent to the company packing house for packing. Dedicated trucks are used to transport products to the packing house. There is no field packing or other post-harvest activity. This is dryland farming and well water from an external supplier is used for crop protection, and a company well is used for potability needs at the packing house. Monthly samples are taken from the water sources. Only one sample is taken for a season of 6 weeks, tests were done 11 days before the beginning of the season. The season this year started in July with harvesting and packing. There are 2 workers for the farm. The packing house operates from July to October or when fruits are available, and packs its own fruits. This is a completely dry operation. Adjacent land is mostly woods residences and other farms, these locations have good buffer areas. At the packing house, fruits are visually inspected, graded/sized, labeled/stickered, and then put into corrugate bins, which are labeled according to size and count. Bins are shipped the same day or within 24 hours of packing. Customers are in charge of the transportation from the packing house. There are approximately 20 workers at the packing house; 6 portable toilets provided by ABC Septics are used at the packing house. These are inspected weekly. The packing house has a HACCP program with no CCPs. There are no allergens in the packing house.
