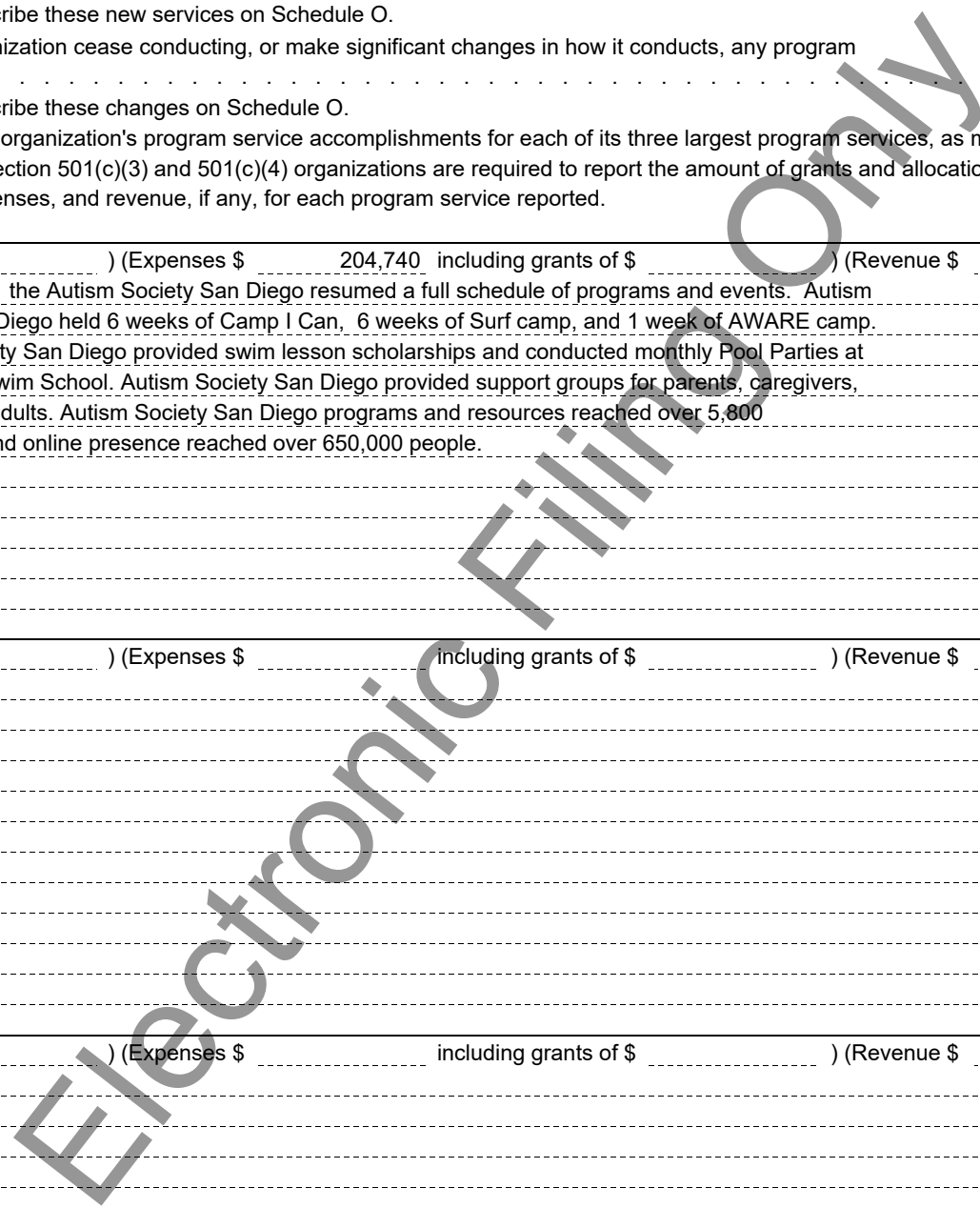

Autism Society San Diego provided swim lesson scholarships and conducted monthly Pool Parties at Aqua Pros Swim School. Autism Society San Diego provided support groups for parents, caregivers, and autistic adults. Autism Society San Diego programs and resources reached over 5,800 individuals and online presence reached over 650,000 people.
