### From our website

LiveCrew Holding SA ("us", "we", or "our") operates <http://www.live-crew.com> (the "Site"). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

### Information Collection And Use

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name ("Personal Information").

### Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

In addition, we may use third party services such as Google Analytics that collect, monitor and analyze the collected data.

## Cookies policy

### What are cookies?

Cookies are small files placed on your device by the website when you visit it. They enable the website to function properly (e.g. by saving your preferences) and can be used to obtain anonymised statistics about the visitors browsing the website.

### How do we use cookies?

Like most websites, we might use "cookies" to enable our website to function properly and to collect information about the browsing experience.

CookieScript Consent	First-party	1 month	This cookie is used by Cookie-Script.com service to remember visitor cookie consent preferences. It is necessary for Cookie-Script.com cookie banner to work properly.
_ga_X3T1NF0KY2	First-party	2 years	This cookie is used by Google Analytics to persist session state.
_ga	First-party	2 years	This cookie name is associated with Google Universal Analytics - which is a significant update to Google's more commonly used analytics service. This cookie is used to distinguish unique users by assigning a randomly generated number as a client identifier. It is included in each page request in a site and used to calculate visitor, session and campaign data for the sites analytics reports.

### How can you manage cookies?

When visiting our website for the first time, you'll be asked to accept or decline the use of cookies. Your preferences will be saved for the next time you will connect on our website. However, you can change your preferences at any time through the cookie icon appearing on the website or through a link in the footer.

### From other internet services

While you might have provided us with Personal Information directly on our website, you might also have provided Personal Information indirectly from other services (such as LinkedIn).

The rest of this document applies to Personal Information collected from any aforementioned sources.

### Communications

We may use your Personal Information to contact you with newsletters, marketing or promotional materials and other business purposes using the information that you provided to us.
