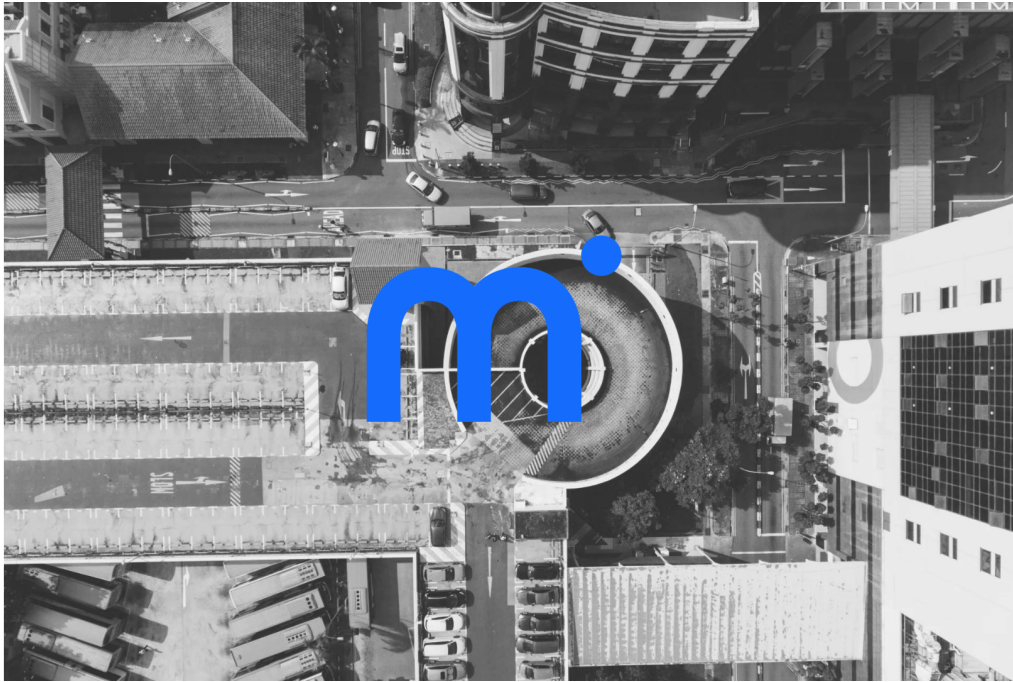

## **1. Information Collection**

1.1 Modii Admin: For authentication purposes, we collect names and email addresses from users who manage and operate parking services.

1.2 Modii Parking Finder: As a publicly accessible service without login requirements, we do not collect any personally identifiable information from users.

1.3 www.modii.co: We collect non-identifiable data from website visitors to enhance site functionality and user experience.

## **2. Use of Information**

2.1 Modii Admin: Information collected is used to authenticate users, provide customer support, and manage user accounts.

2.2 Modii Parking Finder: We use aggregated and anonymized data to improve the service and guide parking management decisions.

2.3 www.modii.co: Non-identifiable data is used for website analytics, performance improvement, and optimization.

## **3. Data Security and Account Management**

3.1 We implement robust security measures to protect user information from unauthorized access and misuse.

3.2 Users can securely reset their passwords for Modii Admin.

3.3 Customer accounts on Modii Admin can be disabled but not deleted, ensuring no access to the system with a disabled account.
