### 4. Cancellation and Termination

b. Jurisdiction: Clients agree to submit to the exclusive jurisdiction of the courts of Dubai, UAE, for any dispute arising from the use of Shopobill.

We disclaim all warranties, including but not limited to warranties of merchantability, fitness for a particular purpose, and non-infringement. We do not guarantee that Shopobill will be error-free or uninterrupted, or that it will meet your specific requirements. We shall not be liable for any damages, whether direct, indirect, incidental, special, or consequential, arising from the use of Shopobill or any content available through the platform.
