## **About MTHA**

The Maryland Thoroughbred Horsemen's Association is the officially authorized organization that represents, assists and promotes the interests of Maryland's Thoroughbred owners and trainers.

Membership in the MTHA is automatically extended to everyone licensed to own and/or train Thoroughbred race horses in this state.

There is no membership fee. The MTHA's many activities and services are supported by a deduction of 2% off the top of purse monies at Maryland's three Thoroughbred race tracks. In addition, benevolence to backstretch workers is supplemented by a per start gate fee.

Guiding the MTHA is a 15-member board of directors, comprised of seven owners, seven trainers and one at-large member (either an owner or trainer). Further leadership is provided by a President and two Vice-Presidents as well as a Treasurer. Day-to-day administration is conducted by an Executive Secretary employed by the association.

Elections for MTHA directors and officers are held at three-year intervals, with each term of service lasting three years.

In addition to a business office, MTHA offices are also in operation during live race meetings at Laurel Park, Pimlico and Timonium:

## Backstretch Pension Program



Retirement benefits for backstretch workers are a reality in Maryland, thanks to a program started by the MTHA in 1988. The Backstretch Pension Fund is derived from monies deducted annually from the Purse Account. Participants do not make individual contributions into the plan.

Sign-ups for the Pension Program are conducted each spring at Laurel Park and Pimlico. At that time, employees must register to receive benefits based on the previous year.

#### **ELIGIBILITY REQUIREMENTS FOR PROGRAM**

Anyone employed in the care of horses on the backstretch in Maryland, including trainers, is eligible to participate in the program.

Employee must have worked a minimum of 1,000 hours during the specified year in Maryland, and provide documentation to that effect (with a W-2 or 1099 form, or tax return) at time of sign-up.

Benefits become available when the employee reaches the age of 65, or at age 55 with 25 years of service.

## Trainer Benefit Trust Fund

Trainers and their spouses can receive a helping hand of limited assistance with medical and dental expenses through the Maryland Thoroughbred Horsemen's Benefit Trust Fund, administered by the MTHA.

Assistance is a founding purpose of horsemen's organizations throughout the country and the MTHA's Benefit Trust is recognized as one of the nation's most robust programs designed to support individuals in need who aren't covered by other programs.

#### **ELIGIBILITY REQUIREMENTS FOR PROGRAM**

Program is need based and open to currently licensed trainers and their spouses facing a financial hardship. Eligible trainers must have been currently stabled at Laurel Park or Pimlico with a minimum of 10 starts in Maryland for at least one year prior to the request. In addition, a majority of the trainer's starts must have been in Maryland during this time.

Eligibility is subject to a review by the MTHA's Health & Welfare Committee.

The following eligible participants receive the following benefits from the program:

#### **TRAINERS**

\$50.00 deductible per bill 90% coverage of balance Up to a maximum benefit of \$5,000 per calendar year

#### **SPOUSE OF TRAINER**

\$50.00 deductible per bill 50% coverage of balance Up to a maximum benefit of \$2,500 per calendar year

If you are in need of assistance, please contact the MTHA Office at 410-902-6842. You will be asked for a copy of your medical bills. No assistance will be offered without proper documentation.

### Backstretch Health & Welfare Fund

Often medical coverage for doctor's visits and prescriptions for people working on the racetrack is either non-existent or quickly exhausted by astronomical costs. MTHA offers medical assistance to backstretch workers on a pre-authorized basis and helps individuals. Also the MTHA can help by scheduling appointments with a medical provider who has agreed to reduce fees for Maryland racing patients.

On occasion MTHA makes direct financial assistance in order to prevent impoverishment of an individual and/or family.

#### **EYE & HEARING CARE**

Eye and hearing examinations, as well as glasses and hearing aids can be expensive. MTHA will offer up to \$200 of assistance per two-year cycle when the need is pre-determined.

#### **DENTAL CARE**

MTHA offers dental assistance on a pre-authorized basis by working with qualified dentists whose charges are based on an agreed fee.

Except in emergencies, the need and cost must be pre-determined\* on an individual basis before dental work is performed.

NOTE: \*predetermined: permission granted before treatments received from a medical provider. Financial limitations apply to each type of service per employee per calendar year.

#### **ELIGIBILITY REQUIREMENTS FOR PROGRAM**

Program is need based and open to licensed backstretch workers in good standing currently employed by a Maryland-based trainer for the past six months.

## Fire Insurance

As a service to Maryland's horsemen, fire and disaster insurance is provided at no cost. Under this policy, MTHA members may be compensated for death or humane destruction of their horses due to a number of perils, including fire, lightning, wind storm, smoke and flood.



Coverage extends to horses located at or in transit to or from Laurel, Pimlico and Timonium. Additionally, horses are covered when in transit from Pimlico and Laurel to race and return from out-of-state tracks.

## **Clothing Drive**



The MTHA Clothing Drive makes necessary clothes, shoe, books, winter coats etc available to backstretch workers in need at Laurel Park via a distribution center open seven days a week.

Two collection bins are easily accessible for donations at Laurel Park located in front of the stable gate and at the horsemen's entrance to the track.

## **Immigration**



The Maryland Thoroughbred Horsemen's Association has contracted the services of a Bethesda-based immigration attorney to help trainers and backstretch employees with issues concerning visas, green cards and general immigration issues.

On behalf of the MTHA, Stein Legal Group will provide general assistance and guidance, and meet with trainers and their employees intermittently at Laurel Racetrack.

Specific work that Stein Legal Group performs for individuals in processing their work visas will be on a contract basis between those individuals and the attorney.

When contacting Stein Legal Group on any specific case or application, they will be able to tell you if the fee for that service falls within the scope of the work that they are doing for the MTHA, or if there will be a specific charge to the trainer/employee for that work.

The fees that the MTHA has contracted for are for general advice and guidance only, and do not include specific applications.

## Thoroughbred Aftercare



The Maryland Thoroughbred Horsemen's Association became a leader in the effort to care for thoroughbreds when it agreed ground-breaking partnership with the Thoroughbred Aftercare Alliance to coordinate activity for retired race horses.

The TAA is designated to accredit aftercare programs and raise and distribute funds among those programs around the country. The MTHA participation with the TAA requires that funds donated by the MTHA are used for horses that have run in Maryland and that the retirement farm also be in Maryland.

In Maryland, the MTHA's thoroughbred retirement program is funded through a voluntary donation of \$6 per starter that most horsemen participate in. A portion of the funds collected by this program will be allocated to TAA, the remaining funds available will be distributed by the MTHA Board to aftercare facilities that do not participate in the TAA program.

Accredited organizations may apply for assistance directly from Thoroughbred Aftercare Alliance's website at thoroughbredaftercare.org.

Non-accredited organizations can apply for a grant by downloading an application at mdhorsemen.com.

## **Obamacare Help**



The MTHA will assist backstretch workers to learn more about and sign up for health care under the new Affordable Care Act.

## **Tax Assistance**



The MTHA Director of Finance Rosemary Lishia will assist backstretch workers and trainers to prepare and file their state and federal tax returns.

## **Health Fairs**



No one likes to think about serious illness. But the fact is—many life-threatening problems can be successfully treated, and even cured, if they are diagnosed at an early stage.

Backstretch Health Fairs, sponsored by the MTHA at Laurel Park and Pimlico, offer screening services that have uncovered many such conditions.

Services include lipid profiling, screenings for blood pressure, body fat composition, carbon monoxide and skin cancer, PSA testing, colorectal counseling, plus seated massage therapy, and more. Health care providers are on hand to answer questions.

The Health Fair schedules are advertised mid-summer.

All services are FREE of charge to all backstretch employees and their families.



The Horsemen's Health System, is a joint effort between MTHA and Maryland Jockey Club that offers medical services—free of charge—to anyone employed in the care of horses, as well as their spouses and families. The program utilizes doctors from the renowned MedStar Sports Medicine network of physicians.

MedStar Sports Medicine is one of the premier sports medicine programs in the country, offering the latest advancements in sports medicine technology. MedStar Sports Medicine has grown to include more than 50 physicians, a team of certified athletic trainers and a network of nurses, therapists, nutritionists, and other clinical support associates at MedStar's 10 hospitals and its network of community-based healthcare services.

Horsemen will be able to utilize Medstar's vast network free of charge for routine medical care. Doctors will be available for walk-ins and appointments on race days, one hour prior to the first post time, until the last race is completed.

On dark days, Medstar physicians are located within a short few miles of both Laurel Park and Pimlico. Transportation can also be provided free of charge via UBER® if need requires.

## Mental Health, Drug & Alcohol Counseling Program

The Horseman's Assistance Program provides services to deal with a wide range of issues including family problems, marital conflict, work stresses, emotional stress, substance abuse and financial concerns.



Jasmine Arian is at your service to provide services and resources to assist in dealing with a wide variety of problems. This problems include: Stress, Depression, Family Problems, Marital Conflict, Anxiety, Grief, Alcohol or Drug Abuse, Financial Concerns, and Legal Issues.

There is no cost to employees for this service. All contacts made with the Horsemen's Assistance Coordinator are held in strict confidence.

It is the Horsemen's Assistance Coordinator's responsibility to find outside resources that provides affordable services to the community. Financial assistance is determined on a case-by-case basis.

The MTHA and Maryland Jockey Club sponsors the Horsemen's Assistance Program.

#### MARYLAND HORSEMEN'S ASSISTANCE FOUNDATION, INC.

The Maryland Horsemen's Assistance Foundation, Inc. is a 501c-3 charitable organization originally established in 1947 to provide necessary financial assistance to eligible employees actively working at Maryland race tracks and/or thoroughbred farms. The Foundation is supported by fines levied by the Stewards and by the Maryland Racing Commission and private donations. It is not financed by legislated percentages deducted from purses.

The MHAF Executive Director administers the Foundation as instructed and authorized by a governing Board of Directors, which consists of owners, trainers and industry officials. Members of the Board of Directors furnish their services without compensation.

The Maryland Horsemen's Assistance Foundation is committed to helping those involved in the Maryland racing community.

## **Burial Assistance**

The Maryland Horsemen's Assistance Foundation owns and maintains burial plots for horsemen not having any family or financial means to arrange for burial service.

If financial need is determined, the Foundation will pay for reasonable private burial expenses which are expected to be kept to a maximum of fifteen hundred dollars (\$1,500).

## General Assistance

Sometimes it is necessary to provide people with financial assistance regarding personal matters not covered by the MTHA's Benefit Trust or Health & Welfare program. These matters include ordinary or extraordinary expenses that people sometimes are unable to meet due to illness in the family, death or possible inability to find work, etc.

In some cases, the Foundation helps with such basics as food, or possibly aids in rehabilitation. Assistance is provided on an individual basis, depending on financial need and other personal factors. These are very often extreme cases in which the individual feels there is nowhere to turn.

The Foundation does, however, require those requesting help to provide financial documents such as past due notices, lease agreements, utility bill, W-2 forms, etc. so that the Board of Directors may judge to what extent assistance is necessary.

## Fellowship Services

The Maryland Horsemen's Assistance Foundation, Inc. provides financial assistance and support many religious fellowship activities at Laurel Park and Pimlico. Services are held on Monday evenings at Laurel Park in the Rec Room at Pimlico in the area outside the racing office.

## How To Request Assistance

To request any assistance you must follow these procedures:

#### **ELIGIBILITY**

To be eligible for assistance, a pre-authorized member of the Maryland racing community must:

- a) Have an up-to-date MRC license.
- b) Be currently employed for a minimum of six (6) months in Maryland.
- c) Be in need of financial assistance. You should be prepared to show proof of income and expenses.
- Contact MHAF's Executive Director before seeking any type of service.
- 2. Fill out the appropriate forms.
- Be approved by the MHAF Executive Director or the Board of Directors via the Executive Director.
- 4. Have your appointment scheduled by the Executive Director.

Once you are pre-authorized, the medical provider will bill the Foundation directly. No payments will be made to an individual.
