A Year's Overview

LETTER FROM CHRISTINA

2021 was a groundbreaking year for She Matters Foundation (Stichting). We overcame the uncertainty from Covid-19 by obtaining an exciting new corporate partnership to support our Lotus Flower Programme, secured vital funding and obtained new board members.

New Partnership with Nike

Our new partnership with Nike was groundbreaking in itself. With this new partnership, we received funding to support 9 participants through an intensive 9-week career readiness programme. True, we've completed several programmes in the past, but this was much more specific in that it provided future-proof skills that the labour market needed: tech skills, supply chain management, self-empowerment and female mentorship.

Most of the workshops were led online by an employee at Nike (even from abroad). The one exception was our self defence workshops, which was facilitated by Synthia Stoffer, founder of JUNO Self Defence.

n addition to receiving a financial to support the programme, Nike generously donated 10 Macbook Pros in which we could use for future Lotus Flower Programmes - what a gift!

In total, all 9 participants graduated from the programme have gone on to secure employment - either via She Matters B.V.

or independently. We are extremely proud of our participants and wish them continued success.

Financial Standing

We received donations totalling €29,607, which included our donation from Nike, George P. Johnson's Christmas campaign, and donations from private individuals via GlobalGiving. We are grateful for this support and couldn't do what we do without it.

New Leadership

Another success in 2021 took the form of new board members. Nhi Phan joined our Supervisory Board in July 2021 and brings a wealth of knowledge in Business and Strategy. In addition, Nevbahar Cuhadar joined our Advisory Board in November 2021. An accomplished business leader, her previous experience includes leadership roles at Nike and Levi Strauss & Co.

Once again, I would like to thank our donors, corporate partners, volunteers and leadership team for their unrelenting support. I can't wait to see what 2022 has in store for us.

Lotus Flower Programme

She Matters Foundation is a not-for-profit organisation with a mission to empower highly skilled refugee women (hereinafter 'female newcomers') to build their social and economic capital, boost their self-confidence and become leaders in their homes, businesses and communities.

Through our signature Lotus Flower Programme, we provide 9-weeks of career readiness training, female mentorship, and job placement opportunities (via She Matters B.V.) to 8-10 female newcomers per programme cycle.

The programme is executed in collaboration with our corporate partners, and through the dedication of our part-time employees and volunteers.

Our Participants

Our programme participants are women, and those who identify as women, who have a refugee or forced migration background. Each has at least a college level degree, previous work experience, a fluency in English and a personal drive to succeed.



Financial Analysis

Income

After the impact that Covid-19 had on the foundation's income in 2020, it was a relief to resume our activities again. Our corporate partnership with Nike in 2021 empowered us with a financial donation, in which we used to implement a Lotus Flower Programme.

We also received funding from private individuals via GlobalGiving and through the George P. Johnson's Christmas campaign.

The total income in 2021 was €29,607.

Costs of the Lotus Flower Programme

The cost for the Lotus Flower Programme totalled €12,143. To help subsidise other costs associated with the programme, Nike's employees helped to coordinate the programme, facilitate the workshops and served as our mentors for our participants.

Nike also covered the costs for our graduation ceremony, which was held at the NH Grand Hotel Krasnapolsky. In total 9 participants graduated the programme, to whom we are extremely proud.

General costs

Our general costs in 2021 concluded at € 8,335 of which €3,372 was recorded for non-reductable VAT.

Result

The foundation's result in 2021 was € 9,109.

Financial Outlook

In the past year the foundation has made excellent progress in concluding a strong partnership with Nike. With this partnership, we were able to resume our activities and obtain vital funding to implement our 6th Lotus Flower Programme.

We aim to continue this model and anticipate partnering with more private sector companies. As a foundation, we are reliant on donations from our corporate partners, corporate funding campaigns and private donors.

Due to the foundation's negative equity and lack of resourced resulting from Covid-19, we had to plan new programmes in line with our income. At the end of the first half year, our income was over €7,000. We aim to plan another programme in the second half of 2022 or early 2023.

In looking towards the future, the Executive Board aims to turn the negative equity around and build new financial buffers to continue our mission.

OUR FINANCIALS

Risk Analysis

The risk profile of the foundation is rather the same as in previous years.

Income Risk

The foundation thanks its donors for our license to operate. To sustain a growing flow of income we are continuously investing in marketing and communications efforts. The foundation has a professional website and is active various social media channels such as Twitter, LinkedIn, YouTube, Facebook and Instagram.

Another approach for increasing our income is to work with ambassadors who stand behind our mission and vision.

Liquidity Risk

The foundation's equity remained negative in 2021; however due to the positive result in 2021 a contribution to its own reserves was made. Our primary focus is to spend the donations as much as possible towards its mission.

Our secondary aim is to strengthen the foundation's balance sheet structure and make contributions to foundation's reserves.

Staff Dependency

The foundation was established by Christina Moreno in 2017, who has been steering the organisation and is overseeing all its activities ranging from fundraising, interviewing applicants, providing career guidance to selected participants, advocacy, programme management and other aspects. This was still the case in 2021.

NOTES TO THE FINANCIAL STATEMENTS

General Accounting Principles

The financial statements have been prepared in accordance with Title 9 Book 2 of the Dutch Civil Code and in accordance with the RJ 650 and RJ 640 guidelines, as set by the Dutch Council for Annual Reporting.

The financial statements are prepared on the basis of the historical costs. All amounts are in euros.

According to Dutch Civil Code the foundation can be classified as a small company and is therefore exempted from external auditing.

Principle of Valuation of the Balance Sheet Items

Assets and liabilities are stated at nominal value or at the lower present value as of the effective date. Profits are only recognised to the extent to which they have been realised on the balance sheet date. Liabilities and possible losses originating before the end of the financial year are taken into account if they were known before the financial statements were prepared.

Principle for the Determination of the Result

The foundation undertakes charitable activities. The income therefore includes donations from third parties, which are mostly exempted from V.A.T. Income is recognised when the foundation has entitlement to the funds

The expenditure is determined on a historical basis and are attributable to the reporting year to which they relate. Due to the potential V.A.T. exemption on income, V.A.T. on expenditures may not be deducted.

The non-deductible V.A.T. (mainly 21%) is separately recorded under general costs. With the foundation's aim of operating a non-profit organisation, there is no corporate income tax applicable.
