

# CAMP FORGE INFORMATION SHEET



## LOCATION

Camp Forge is held at Quaker Meadow Christian Camp located at Western Divide Highway and Forest Route 21S78, Springville, CA 93265

## CAMP DATES

Camp opens with check-in at 2:00 pm Monday, July 31st, and camp will conclude at 11:00 am Friday, August 4th.

## CHECK-IN

Check-in and cabin assignments will take place on Monday, July 31st, from 2:00 pm through 3:00 pm. Please arrive within that time frame.

## PAYMENTS

Individual payments should be made out to your home church. Each church should bring **one check** to camp for their group, made out to Faith Baptist Church.

## CONSENT & RELEASE FORMS

Each Consent and Release Form should be turned in to your Youth Director. Each counselor should have a signed Consent and Release Form for each teen from their church and keep it in their possession in case of emergency.

## REGISTRATION

A \$50 non-refundable registration fee is due on Wednesday, June 25th for each Camper & Counselor (this \$50 is credited toward the total \$250 balance). The remaining balance is due and payable when you arrive at camp. Any registration received after June 25th will be assessed a \$25 late fee.

## IMPORTANT CAMP POLICIES:

### Code of Conduct

- No alcohol, tobacco in any form, listening to or watching electronic devices, fireworks, or weapons of any kind
- No physical contact allowed between male and female campers
- No clothing or accessories with inappropriate advertising.
- No boys around girl's cabins, and no girls around boy's cabins
- Obey dress code to and from swimming area

### Clothing and modesty

#### Service times

- Men - pants and tee shirts for all morning services, and a collared shirt for the evening services
- Ladies - modest culottes, or skirts for all morning services (tee shirts are acceptable), and a nicer blouse or dress for the evening services

#### Activity and free time

- Men activity time - shorts that go to knee and tee shirts
- Ladies' activity time - culottes or modest "board shorts" that go to the knee
- Ladies' swimwear – modest shorts and dark colored shirt – No bikinis. Must be fully covered to and from swim time
- Men's swimwear – modest short and dark colored shirt

## CONSENT AND RELEASE FORM FOR CAMP FORGE

I expressly agree that this release, waiver, and indemnity agreement is intended to be broad and inclusive as permitted by the law of the State of California, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This release contains the entire agreement between the parties hereto, and the terms of this release are contractual and not a mere recital.

I further state that **I HAVE CAREFULLY READ THE FOREGOING RELEASE AND KNOW THE CONTENTS THEREOF AND I SIGN THIS RELEASE AS MY OWN FREE ACT.** This is a legally binding agreement, that I have read and understand.
