This is in accordance with the General Statute 115C-434 that NERSBA hereby authorizes an interim appropriation for the purpose of paying salaries and the usual ordinary expenses of the administrative unit for the interval between the beginning of the Fiscal Year and the charge to the proper appropriations in the 2018-2019 Budget Resolution.

2. NERSBA Budget Amendment #3

~Budget by Fund total \$2,377,866.92

~Fiscal Year 18-19 was an increase of \$840.00 for State Funds for NCVPS sure up. Federal Funds were reduced by \$3,187.00 due to a reduction in number of EC student head count.

~State per budget amendment for instructional service accounts for approximately 70.8% of the overall budget. In other words, \$70.80 out of every \$100.00 is budgeted to go directly into the classroom or directly impact instruction. Funds were redirected to Instructional from System Wide Services to provide additional supplies and equipment.

~Local- No change.

~Federal – Reduction in funding.

~G5- No change.

2018-2019 Financial Report:

~Year to Date Funds: Final payments form LEA's are expected soon.

~State Funds: YTD Expenditures of \$1,677,081.60, 89% with remaining balance of \$201,180.40. Last payroll will be running and remaining invoices received will spend down balance of state dollars to zero.

~Federal Funds: YTD expenditures of \$355,831.92, 77% with remaining balance of \$105,608.08, this may rollover to fund balance depending on lawyer fees.
