## 2. Scholastic Report: Mr. David Jenkins

Mr. David Jenkins provided an informational document outlining testing data and scholastic proficiency at NERSBA during the last four years. Data including a comparison of North Carolina Grade Level Proficiency (NCGLP) College and Career Promise (CCR) Data, High School Graduation Rate, School Grade and Growth was also noted during his presentation. As a point of reference, the NERSBA Early College received a B and met Expected Growth during the 2022-2023 school year.

### 3. Financial Report: Mr. Hal Davis

## 3.1 2023-2024 NERSBA Early College Fiscal Report: Mr. Hal Davis

Mr. Davis informed the board that the North Carolina General Assembly is close to finalizing a state budget for the 2023-2024 fiscal calendar. The proposed plan would include pay increases for teachers, retirees and resources to support social and emotional learning for schools.

Once the budget has been finalized and forwarded to individual local educational agencies, the NERSBA Finance Committee will meet to finalize our operational budget for 2023-2024 academic year.

## 4. Information Items: Mr. Hal Davis

## 4.1 Legislative Update: Mr. Hal Davis/Mr. Benjie Forrest

As noted earlier, Mr. Davis reported that NERSBA is still waiting on a budget and further information regarding the requirement that teachers post lesson plans online as required in the Parent Bill of Rights. Clarification regarding the Parental Bill of Rights will be provided in the near future. This document will become effective January 1, 2024.

Mr. Benjie Forrest suggested to Mr. Davis that he review the Pitt County Schools website to how they have the Parent Bill of Rights information posted and how they plan to post teacher lesson plans.

## 4.2 American FFA Degrees Candidates/National FFA Convention Planning:

Mr. Davis informed that board that three former NERSBA scholars will be receiving the American FFA Degree during the National FFA Convention scheduled in early November.

These students are: Logan Wallace, Gabe Wynn and Katie Harris.

Mr. Davis also informed that board that twelve scholars from NERSBA will be attending the National FFA Convention to be held in Indianapolis, Indiana with faculty members Mrs. Maria Dickerson and Mrs. Kristie Hardison.

## 4.3 Classified Employee Salary Schedule: Mr. Davis

Mr. Davis has reached out to Dr. Larry Price to review classified employee salaries from several local educational agencies. Mr. Davis noted that he plans to provide an additional update regarding a proposed salary schedule for classified employees at the October board meeting.
