# 2.0 NERSBA Scholastic Report: Mr. David Jenkins

Mr. Jenkins provided a number of informational updates regarding the current status of the 2024 spring semester. He noted scholastic field trips, testing schedules and the Regional Envirothon to be held at the Cool Springs Park in Craven County.

Mr. Jenkins also provided information to the board regarding the implementation of the Infinite Campus Software Suite Platform that will be replacing PowerSchool. Mr. Jenkins noted that Mrs. Deidra Mason (the NERSBA Data Coordinator) will be facilitating this transition for our NERSBA Early College.

## 3.1 2023-2024 NERSBA Early College Fiscal Report: Mr. Michael Hardy/Hal Davis

Mr. Hardy and Mr. Davis have met on a regular basis to review state line items outlined in our budget. Mr. Davis, Mr. Griffin and Mr. Forrest met with Mr. Hardy recently to acknowledge state and local budget expenditures and current balance line items in preparation for end-of-year closeouts. # 5.3 2024-2025 Student Handbook Revisions: Mr. David Jenkins

Mr. David Jenkins reported on the promotion requirement update for new credit requirements (located on page 7 of the current NERSBA Student Handbook). Mr. Jenkins requested that promotion requirements at NERSBA be revised to increase rigor among our scholars (the new requirements are outlined below).

Mrs. Vanessa Cherry moved to approve the revisions, as presented by Mr. David Jenkins. Mr. Jerry Phelps seconded the motion. The motion was approved with a majority vote by the NERSBA board membership.

## New Promotion Standards Effective March 20, 2024

- *Grade 9 to 10* -- Will change from five credit requirements to the proposed six-credits including English I and a social studies course
- Grade 10 to 11 Will change from ten credit requirements to 13 credits including English I and II, two credits of social studies, Math 1 and II, and one science credit
- Grade 11 to 12 20 credits to include English I & II, Earth & Environmental Science, Biology, Math I, II, and III, in addition to two social studies credits
