It was indicated a demolition permit for the old ride was given. It was indicated there was not enough information on the site plan provided. The applicant explained the tower is temporary to collect data to decide if they would move forward with a wind project. The tower would be centrally located to where the possible wind farm would be in the future. It was indicated that Taku Wind is the builder and will provide maintenance, while Dan Miller is the property owner. They are a company out of Washington, D.C. that handles the permits and land acquisition for building energy. They do not currently have any other sites in our area. Jay Blatchley made a motion for forward this matter to county. Brandon Calmes second. All ayes. This matter will be forwarded to the Genesee County Planning Board. A public hearing is set for December 18, 2017 at 8:00p.m.
