#### **Portfolio**

The portfolio of Entweder has extended its growth in 2022: within this section, you can read about what this meant for the different ventures.



<u>Campus Offices</u> started four years ago with the first campus location in Enschede (Campus CeeCee) and has currently grown its portfolio into 17 different buildings as of today. They have secured multiple new rental agreements in 2022, including notable ones with Qredits (Campus Dreesz) and Ricoh (Campus Hambaken), totalling over 13.500 square meters of office space. The Campus team has also been working hard to expand its offerings to better meet the needs of a hybrid workforce. This resulted in the introduction of a range of flexible office products.



BOW has also extended its growth. In 18 months, they have transformed from a start-up into a scale-up, with its number of dealers increasing to a total of 40. They have also expanded internationally, securing their first dealers in Belgium and Germany. In addition to this growth, BOW has also introduced a new version of its modular product which is much easier to assemble and has a much more attractive design. They have also developed their own configurator which is directly connected to the stock levels of BOW. The configurator is set to be launched in Q1 2023.

#### **□SKEPP**

In 2020, <u>SKEPP</u>, a second venture within the Entweder portfolio, diversified its business by becoming an office outfitter in addition to its original role as a digital-first office broker. This new part of SKEPP has experienced 60%+ growth in 2022 compared to the previous year, without the brokerage side suffering from it. SKEPP also entered the German market next to its native Dutch one. The operation of SKEPP Deutschland has found its product-market fit and the right distribution structure during this year. Based on this further growth will be possible in the following years.

#### New year, new ventures

#### office manager

Officemanager is an all-inone solution for turning the office from a product into a service, offering both software and hardware components. The system is plug-and-play, requiring no adjustments to the existing building services or structures.

#### HOLD

**HOLD** is a tech-enabled general contractor for circular wooden office buildings. They combine modular building system with cutting-edge technology to design and build future-proof office buildings. The system consists of three parts: the structure, building services, and flexible partitioning - making sure it's a fully circular solution.



Besides working on the five current ventures, the Entweder team also worked on new possible ventures. This was done based on the S5 model to make sure that more ventures will be incorporated in 2023.

#### **People**

When it comes to people there has been significant growth at Entweder over the past year. In fact, the total number of employees has increased by 42,5% while the number of full-time equivalents (FTE) has grown by 38,9%. This growth is partly due to the fact that several new founders have joined Entweder.



We are excited to report that Entweder has seen a significant increase in both our internal valuation and the growth of the total revenue. In 2022, we saw a 33.6% increase in our internal valuation and a 58.3% increase in revenue. This growth is a great result of the hard work and dedication of all team members and other stakeholders who have contributed to it.
