### 1. What is a cookie?

Cookies are data placed on your computers or mobiles. They are distinguishable by their unique identifiers, associated with your computers or phones. They prevent you from having a poor consumer experience on your favorite sites, as they remember your actions and preferences. Thus, you do not need to enter your browsing preferences each time you use it, such as location, font, or language.

These "cookies" are stored in your computer's RAM. They do not allow us to identify you; however, they record information related to your computer's navigation on the Site (the pages you have visited, the date and time of the consultation, etc.) that we can read during your subsequent visits.

For all Data Processing related to the collection of cookies, Phone Recycle Solution, [Simplified Joint Stock Company (SAS) with a share capital of 1,000,000.00 euros, having its registered office located in Paris at 189 rue d'Aubervilliers (75018) and registered in the Paris Trade and Companies Register under identification number 831 008 842.], determines the means and purposes of the Processing. Thus, Phone Recycle Solution acts as a Data Controller, within the meaning of the Regulation relating to Personal Data, and in particular Regulation (EU) 2016/679 on the protection of natural persons with regard to the Processing of Personal Data and on the free movement of such data.

Phone Recycle Solution attaches the utmost importance and care to the protection of privacy and Personal Data, as well as to compliance with the applicable Legislation.

The purpose of this Cookie policy (hereinafter the "Policy") is to provide you with simple, clear information on how your Data is collected through the cookies deposited on the internet.

### 2. Are cookies deposited when you browse the website?

During your first visit to the website, a banner informs you of the presence of these cookies and invites you to indicate your choice. Cookies requiring your consent in accordance with the regulations are only deposited if you accept them. You can at any time inform yourself and configure cookies to accept or reject them by going to the Cookie Management page at the bottom of each page of the site or by configuring your browser.

### 3. What data is collected through cookies?

Can be collected, via cookies all the data that relate to a terminal at a given moment including:

One or more technical identifier(s) allowing to identify your internet box

The date, time and duration of connection of a terminal to a website;

The Internet address of the source page of the terminal accessing the website;

The type of operating system of the terminal (e.g. Windows, MacOS, Linux, Unix, etc.);

The type and version of the browser software used by the terminal (Internet Explorer, Firefox, Safari, Chrome, Opera, etc.);

The brand and model of the mobile terminal or tablet;

Possible download errors;

The language of use of the browser software used by the terminal;

The characteristics of the consulted and shared contents;

### 4. What are the purposes of collected cookies?

On the site, we can deposit different types of cookies for several purposes:

Cookies necessary for the personalization and operation of the website: they allow you to use the main functionalities of the Site and in particular to save information between two consultations of the site on the same device, to record session login identifiers or elements of interface customization (choice of language or presentation). They do not require your prior consent. These cookies are essential for the proper functioning of the Site. If you refuse the recording of these cookies in your device or its browser, or if you delete those that are recorded, you will be informed that your navigation and your experience on the Site may be limited.

Analytical cookies, statistics or site audience measurement cookies, which allow us to know the use and audience performance of the site and to improve its operation for our visitors. For example, to establish statistics and volumes of frequency and use of the various elements making up the site (sections and contents visited, routes), in order to improve the interest and ergonomics of the site.

## **6. How to manage your consent to cookie deposition?**

The deposit of a cookie for purposes of audience measurement, content personalization, social networks and targeted advertising requires your prior consent. This consent is requested through the banner that is displayed during your first navigation on the site. You can choose to accept the deposit of cookies for all the purposes listed, refuse them, or customize your choice. You can withdraw your consent at any time by going to the [Cookie Management] page at the bottom of each page of the site.

## **7. How to configure cookies on web browsers?**

You have the option to configure your browser to accept or reject all cookies, delete cookies periodically, or even see when a cookie is issued, its validity period, and its content, and refuse its recording on your hard drive.

You can choose to block or disable these cookies at any time by setting the internet browser on your computer, tablet or mobile, in accordance with the instructions established by your internet browser provider and appearing on the websites mentioned below:
