

Fruitful, Inc. - One Month Free Promotion - Terms and Conditions

The following terms and conditions apply to the promotional offer of "One Month Free Membership" (valued at \$98) at Fruitful, Inc. ("Promotion"):

Eligibility

The Promotion is open to legal residents of the United States, aged 18 years or over who have never had a Fruitful membership.

Promotion Period

The Promotion begins on July 20, 2023 and ends on December 31, 2023 at 11:59 PM EST.

How it Works

To participate in the Promotion, eligible individuals must sign up for a Fruitful membership at www.fruitful.com and enter a valid promotional code provided at the time of sign-up. Promotional codes cannot be applied after sign-up.

Promotional Code
