

Notice of Rule Filing to Continue Suspending the Application of Rule 11.190(f)(1) Until December 8, 2020

Long-Term Stock Exchange. ("LTSE") has filed a rule change to continue to temporarily suspend Rule 11.190(f)(1), Order Price Collars, until December 8, 2020. The filing to the Securities and Exchange Commission regarding this rule change is available here.

The Order Collar provisions of Rule 11.190(f)(1) are a prophylactic measure to prevent trade executions outside of certain price bands. The Exchange has in effect other provisions to address trade executions at prices outside of these price bands, such as Rule 11.270 (Clearly Erroneous Executions).
