INTRODUCTION

Valour Binance (BNB) SEK is an exchange-traded product tracking the price of BNB, the native cryptocurrency issued by the Binance exchange and running on the Binance chain. It can be used for payments on transaction fees (on the Binance Chain), travel bookings and other payments. Valour Binance (BNB) SEK ETP makes investment in this ecosystem simple, secure and costeffective, available for purchase on regulated stock exchanges via any bank or broker. The product is a structured investment under Swedish law and traded on the Nordic Growth Market Oy in Sweden

CALCULATING THE PRICE OF **VALOUR BINANCE (BNB)**



We calculate the arithmetic mean price from major exchanges¹



Using market rates, we convert the dollar value of Binance (BNB/USD) into the product currency (SEK)



We deduct an annual management fee daily on a pro rata basis



We apply the multiplier 0.001 to set the price of one certificate, making it an affordable unit price

1 The reference price is set using the average price of the underlying (BNB/USD) from the one most liquid
