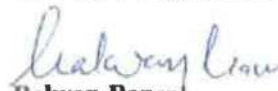

Dear Sir/Madam,

In pursuance of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI circular No. CIR/CFD/CMD1/114/2019 dated October 18, 2019, this is to inform you that the Statutory Auditor of the Company viz. M/s B. B & Associates, Chartered Accountants (FRN: 023670N) have expressed their unwillingness to continue as Statutory Auditors of the Company for the Financial Year 2022-23 vide their resignation letter dated May 14, 2022.

Reason for Resignation: Pursuant to applicability of IND-AS, the audit fee was required to be negotiated for FY 22-23. The auditors were not in agreement with the fees proposed by the management for FY 22-23, therefore, they have decided to resign as the auditors of the Company.

Their resignation letter dated May 14, 2022 alongwith information required from the Auditor in pursuance of SEBI circular no. CIR/CFD/CMD1/114/2019 dated October 18, 2019 is enclosed herewith as **Annexure-I**.

In terms of the provisions of SEBI circular no. CIR/CFD/CMD1/114/2019 dated October 18, 2019 and as stated in the resignation letter of the Statutory Auditors, the resignation of the Statutory Auditors shall be effective from the date of submission of the Audit report, after submission of the audit report for the quarter and year ended March 31, 2022.

The Audit Committee and the Board of Directors of the Company on May 14, 2022 have noted the resignation of the Statutory Auditors and the fact that the existing Statutory Auditors have not raised any concern or issue and that there is no reason for resignation other than as stated in their resignation letter dated May 14, 2022.

As you are aware, we were appointed as the Statutory Auditors of E2E Networks Limited ('the Company'), pursuant to the shareholder's resolution dated September 28, 2018 to hold office for a period of 5 consecutive years till the conclusion of Annual General meeting of the Company to be held for the financial year 2022-2023 in the year 2023.

We are in process of completing our statutory audit for the year ended March 31, 2022.

Further, since the Company has migrated to the main Board of the NSE w.e.f April 12, 2022 and therefore IND-AS has become applicable and there was major change in scope of work, we discussed about the increase in our audit fees with the management and an agreement on the fee could not be arrived at. Considering the proposed audit fees is not commensurate with the time and efforts involved in carrying out the audit, we would not be in a position to continue as statutory auditors of the Company. We have also discussed this matter with the management of the Company.


Please accept our resignation and effective date of resignation shall be the date of Completion of statutory audit and submission of audit report for the financial year ended March 31, 2022 as required by SEBI circular CIR/CFD/CMD1/114/2019 dated October 18, 2019.

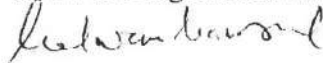
