



PRIVACY RESPECT POLICY

This Privacy Respect Policy aims to formalize our commitment to respecting the privacy of users when they use Aptero.

As part of providing Aptero, we process your personal data in accordance with the General Data Protection Regulation (GDPR) 2016/679 of April 27, 2016, and the conditions outlined below.

Personal data refers to any information relating to an identified or identifiable natural person. We collect and process personal data solely within the scope of providing our Services or communicating about these Services, strictly in compliance with the GDPR.

We only collect adequate, relevant, and limited personal data necessary for the purposes for which they are processed. You will never be asked to provide personal data considered as "sensitive," such as racial or ethnic origins, political, philosophical, or religious opinions.

By registering on Aptero, you authorize us to process your personal data in accordance with this Policy. If you do not agree with the terms of this Policy, please refrain from using our Services.

Under what circumstances do we collect your personal data and what data is collected?

We may collect and retain your personal data, including when you:

- Navigate through Aptero
- Engage in actions on Aptero that involve the collection of personal data, such as account creation, online payment, etc.
- Contact us

We use your personal data to enable the implementation and management of Aptero Services and to respond to your specific requests. We also use your personal data to operate and improve our Services, solution, and approach. This information is used solely by us and helps us better tailor our Services to your expectations.

If you have opted to receive emails and messages from us when creating your Account, you will receive electronic and alphanumeric messages about our products and promotions. We will use the personal data you provided during your registration. You can unsubscribe from these communications at any time.

Navigating Aptero

Connection Data: Whenever you log into Aptero, we collect personal data such as your IP address and computer's MAC address, connection date and time, and information about the browser you are using.

Browsing Data: We also collect information that identifies how you access Aptero, which pages you visit, and how long you stay. In this context, we may use Cookies as specified in paragraph 6 below.

Account Creation

Access to certain of our Services requires the prior creation of an Account. In accordance with the General Terms of Service, you will be required to provide a certain amount of personal data when creating your Account, including your name, surname, and email address.

How do we protect your personal data?

We have implemented technical and organizational security measures to ensure the security, integrity, and confidentiality of all your personal data, in order to prevent them from being altered, damaged, or accessed by unauthorized third parties. We provide an appropriate level of security, taking into account the state of knowledge, implementation costs, and the nature, scope, context, and purposes of processing, as well as the risks and their probability.

However, it is important to note that no security measure is infallible, and we cannot guarantee absolute security for your personal data.

Furthermore, it is your responsibility to keep the password to access your Account confidential. Do not share this information with anyone. If you share your computer, remember to log out before leaving our services.

How long do we retain your personal data?

We will only retain your personal data for the duration of your registration on Aptero in order to ensure your identification when logging into your Account and to provide the Services.

In any case, we will retain your personal data for a period not exceeding that necessary for the purposes for which they are processed, in accordance with the uses outlined in this Policy.

Cookies: How do we use them?

What is a cookie?

A cookie is a text file that may be deposited in a terminal when consulting an online service using browsing software. A cookie file allows its issuer, for the duration of its validity, to recognize the relevant terminal each time it accesses digital content containing cookies from the same issuer.

In any case, cookies deposited on your browsing terminal with your consent are destroyed 13 months after being deposited on your terminal.

What are the cookies issued in Aptero used for?

The cookies we issue allow us to:

 Establish statistics and traffic volumes and usage of various elements of our Aptero solution (sections and content visited, pathways), enabling us to improve the interest and usability of Aptero.

- Adapt the presentation of our Aptero solution to the display preferences of your terminal (language used, display resolution, operating system used, etc.) during your visits, based on the hardware and viewing or reading software present on your terminal.
- Store information about a form you filled out on Aptero (registration or account access).
- Allow you to access reserved and personal areas of Aptero, such as your Account, using identifiers or data you may have previously provided to us, and to implement security measures, for example when you are asked to reconnect to content or a service after a certain period of time.

What are your rights?

You are the sole source of the data we possess, through our solution. You have rights over your personal data. In accordance with regulations on the protection of personal data, including articles 15 to 22 of the GDPR, and after verifying your identity, you have the right to request access to the personal data concerning you, as well as rectification or erasure of such data.

Furthermore, within the limits set by law, you also have the right to object to processing, limit it, determine the post-mortem fate of your data, withdraw your consent at any time, and exercise your right to data portability.
