OPERATIONS

CUSTOMERS AND NEW BUSINESSES

During the summer this year the majority of the shares in Observit AB were distributed to SpectrumOne's shareholders and in the beginning of October our subsidiary Ådata Infosystems was sold. All focus will now be on streamlining and refining operations in our remaining subsidiaries.

REVENUE AND EARNINGS

The consolidated income statement for the third quarter of 2022 comprises the parent company SpectrumOne AB as well as the subsidiaries; VMSPlay Sweden AB, BizWell Sweden AB, Qbim AB, Cloud Explorers AS, Ådata Infosystems AB, the Trigger Company AB, OY Cemron AB, Ampilio AB, Growth Ads Europe AB and Cloudify AB.

Third quarter

Net sales for the third quarter of the year amounted to SEK 14.0 (16.2) million, a decrease of SEK 2.2 million. The decrease in net sales is due to the fact the the former subsidiary Observit AB is no longer considered a subsidiary since the majority of its shares have been distributed to the shareholders of SpectrumOne earlier this year. The gross profit amounted to SEK 7.7 (12.1) million for the consolidated operations, with a gross margin at 54 (75) %.

Operating expenses excluding direct costs and depreciation amounted to SEK 9.8 (24.1) million. The personnel costs have decreased from SEK 6.9 million to SEK 5.8 compared to Q3 2021 due to the change in group structure. Depreciation and amortizations amounts to SEK 21.4 (19.1) million including our associated company Eniro Group AB (publ). Our share of the result for Eniro amounted to SEK 15.3 (4.1) million

Operating profit (EBIT) for the period amounted to SEK -7.1 (-17.3) million. The operating margin is negative. Net financial items amounted to SEK -0.7 (-1.2) million. Profit before tax for the period amounted to SEK -7.8 (-18.6) million. Earnings per share before dilution amounted to SEK -0.02 (-0.05).

First nine months

Net sales for the first nine months amounted to SEK 59.9 (37.8) million, an increase of SEK 22.1 million. The gross profit was SEK 30.8 (27.1) million for the consolidated operations, with a gross margin at 51.5 % (71.8%). Operating expenses excluding direct costs and depreciation amounted to SEK 62.0 (31.7) million. Depreciation amounts to SEK 64.0 (59.5) million including share of earnings from associated companies. The depreciations have increased compared to last year mainly because of investment in Eniro Holding AB shares. Operating profit (EBIT) for the period amounted to SEK -50.9 (-62.0) million. Net financial items amounted to SEK -5.3 (-7.9) million. Profit before tax for the period amounted to SEK -56.1 (-69.9) million. Earnings per share before dilution amounted to SEK -0.02 (-0.02).

CASH FLOW AND FINANCIAL POSITION Third quarter

Cash flow from operating activities before changes in working capital amounted to SEK -1.7 (0.5) million for the third quarter. Changes in working capital have affected cash flow by SEK 0.9 (5.7) million. Cash flow from operating activities after changes in working capital amounted to SEK -0.8 (6.4) million. Investment activities had a cash flow effect of SEK -2.3 (-16.5) million during the period which regards to investments work performed for it's own use and capitalized. Cash flow from financing activities was SEK 6.4 (13.9).

First nine months

Cash flow from operating activities before changes in working capital amounted to SEK

-9.1 (-10.4) million for the first nine months. Changes in working capital had a negative impact on cash flow of SEK -4.1 (-8.1) million. Cash flow from operating activities after changes in working capital amounted to SEK -13.1 (-18.5) million. Investment activities affected cash flow negative during the period with SEK -7.6 (-108.1) million mainly due final payments of the acquisition of the subsiduary Ampilio and work performed for Its own use and capitalized. Financing activities amounted to SEK 16.4 (75.4).

EQUITY AND SHARE

The number of registered shares at the end of the quarter amounted to 374 220 904. The company's equity ratio amounts to 61.6 (79.2) %. The decrease in equity ratio is mainly due to the distribution of the shares in Observit AB. The quota value for the SpectrumOne AB:s shares is SEK 0.1 per share.

Investments

No material investments in tangible assets was made in the third quarter.

Personnel

The number of employees at the end of the quarter amounted to 46 (19) persons, of which 2 persons receive compensation through invoicing from their own companies.

Parent company

The operations of the parent company include group management, finance and IR / PR. The parent company's turnover for the third quarter, which in its entirety is intra-group, amounted to SEK 0.3 (0.3) million. Profit before tax for the period amounted to SEK -0.2 (-2.3) million.

Transactions with related parties

Fredric Forsman, chairman of the board, has during the quarter invoiced the Company for legal services amounting to SEK 360,000.
