

Full information clause – Delikatesy Centrum

1. The controller of your data is DELIKATESY CENTRUM SP. Z O.O. seated in Komorniki at ul. Wiśniowa 11, 62-052 Komorniki. You can contact the Controller by e-mail iod_dc@eurocash.pl or by phone at 613332275, or by writing to the Controller's address.
2. The Controller has appointed a Data Protection Officer (hereinafter "DPO"), who you can contact by e-mail iod_dc@eurocash.pl or by phone at 613332275, or by writing to the Controller's address. The DPO can be contacted regarding all matters connected with the processing of personal data and exercising rights related to the processing of data.
3. Your personal data will be processed in order to manage your enquiry sent through the contact form; the legal basis of the processing is the necessity to process in order to perform the service agreement (Art. 6 par. 1 letter b GDPR); in the scope of optional data, the legal basis is consent (Art. 6 par. 1 letter a GDPR).
4. Your personal data can be transferred to entities processing personal data, i.e. suppliers of IT services.
5. Your personal data will be processed for a period necessary to provide a reply to your enquiry. The period of processing of personal data can be each time extended by a limitation period of claims if the processing of personal data is necessary to establish and pursue claims, if any, and for the controller to defend against such claims.
6. You have the right to access your data, to transfer your data, demand it be rectified, erased or its processing be limited. Insofar as the legal basis of processing is the Controller's legitimate interest, you have the right to object to the processing for reasons connected with your specific situation. In case data is processed under consent, you have the right to withdraw consent at any time; this, however, does not affect the legality of processing conducted by the controller until the withdrawal.
7. You also have the right to lodge a complaint with a supervisory authority dealing with the protection of personal data in the member state of your habitual residence, place of work or place of the alleged infringement. In Poland, such authority is the President of Personal Data Protection Office.
