**Number of shares admitted to trading as at 30 April 2010**

**Current report No. 19/2010**

The Management Board of Eurocash S.A. (hereinafter “**Eurocash**”) announces that it obtained information from UniCredit CAIB Poland S.A., performing the function of the offeror of series E ordinary bearer shares with a value of PLN 1 each (hereinafter “**Series E Shares**”) issued in the scope of the conditional increase of the share capital in relation to the Third Employee Incentive Scheme (compare Report 13/2006 containing the text of the resolution no. 19/2006 of the General Meeting of Eurocash concerning the III Employee Incentive Scheme, Report 48/2008 on the issuance of series D bonds with pre-emptive rights, and Report 56/2009 on determining the issue price of series E shares) that from 1 to 30 April 2010, 24,000 Series E Shares were issued.

Accordingly, as at 30 April 2010, a total of 135,270,736 shares of Eurocash were admitted to trading on the Warsaw Stock Exchange.
