**Correction of the typographical error in the interim report for the 1<sup>st</sup> quarter of 2010**

Legal basis:

Report body:

The Management Board of EUROCASH S.A. (hereinafter “Eurocash”), announces that in the report for the 1<sup>st</sup> quarter of 2010 published on 12 May 2010, as a result of a typographical error in the Discussion of the financial results for the 1<sup>st</sup> quarter of 2010 item 1. Basic financial and operating data for the 1<sup>st</sup> quarter of 2010, erroneous data regarding Cash&Carry LFL sales was provided:

Is:

- The increase in the sales for the fixed number of Eurocash Cash&Carry discount warehouses (increase in LFL) with the exception of the Batna warehouse amounted to 8.12% compared with 3.88% in the 1<sup>st</sup> quarter of 2009.
- Without taking into account the category of tobacco products and telephone cards, the increase in sales for the fixed number of warehouses (with the exception of the Batna warehouse) amounted to 8.94% in the 1<sup>st</sup> quarter of 2010 compared with 4.73% in the 1<sup>st</sup> quarter of 2009.

Should be:

- The increase in the sales for the fixed number of Eurocash Cash&Carry discount warehouses (increase in LFL) with the exception of the Batna warehouse amounted to 4.39% compared with 3.88% in the 1<sup>st</sup> quarter of 2009.
- Without taking into account the category of tobacco products and telephone cards, the increase in sales for the fixed number of warehouses (with the exception of the Batna warehouse) amounted to 5.23% in the 1<sup>st</sup> quarter of 2010 compared with 4.73% in the 1<sup>st</sup> quarter of 2009.

The errors are editorial in nature and did not affect the final financial results of the Eurocash Group for the 1<sup>st</sup> quarter of 2010 which were calculated correctly. In relation to the above, the remaining elements of the corrected consolidated interim report of Eurocash S.A. for the 1<sup>st</sup> quarter of 2010 remain unchanged.
