- 3. ING Otwarty Fundusz Emerytalny: 6,843,714 ordinary bearer shares which entitled to 6,843,714 votes at the Extraordinary General Meeting and which constituted 7.35 % of the votes at the Extraordinary General Meeting; share in the general number of votes of the Company: 5.02 %.

The total number of votes arising out of all issued shares of the Company as at the date of the Extraordinary General Meeting was 136,248,818 votes (which constitutes a difference between the general number of all shares of the Company as at the date of the Extraordinary General Meeting and the amount of own shares). Shareholders representing a total of 93,062.807 votes, that is, 68.30 % of the general number of votes participated in the Extraordinary General Meeting.
