The Management Board of Eurocash S.A. (hereinafter “**Eurocash**”) announces that it obtained information from UniCredit CAIB Poland S.A., performing the function of the offeror of series E ordinary bearer shares with a value of PLN 1 each (hereinafter “**Series E Shares**”) issued as part of the conditional increase of the share capital in relation to the Third Employee Incentive Scheme (compare Report 13/2006 containing the text of the resolution No. 19 of 2006 of the General Meeting of Eurocash concerning the III Employee Incentive Scheme, Report 48/2008 on the issue of series D bonds with pre-emptive rights, and Report 56/2009 on determining the issue price of series E shares), that during the period from 1 to 31 October 2010, 16,958 Series E Shares were issued. Accordingly, as at 31 October 2010, a total of 136,348,721 shares of Eurocash were admitted to trading on the Warsaw Stock Exchange.
