What is the reason Cortlex is changing its name?

Our marketing department decided to change the name to align our branding with our goals and new services. Additionally, we wanted to unify our legal entity and brand under one name. Previously, they were different, and by consolidating them, we aim to enhance consistency and clarity in our corporate identity.

Why "Sigli?"

There will be **no need to resign contracts** as our legal entity will change the name to Sigli, but the **tax number will not change.** The bank will be notified about the name change; this is an administrative detail you won't have to worry about. **Our new name is already registered under the same legal entity.** You can check it in the official <u>Directory of Lithuanian companies</u>. All the changes can be checked in the history at the bottom of the website.

We will do our best to make sure this process is seamless and painless on your side.

Will there be changes to the management team or company structure?
