

Privacy Policy for M-Events

1. Introduction

M-Events ("we," "us," or "our") is dedicated to safeguarding your privacy and ensuring the protection of your personal information. - **b.** Legal Requirements: When required by law, we may disclose your information to comply with legal obligations, protect our rights and safety, or in response to lawful requests by public authorities.

We employ appropriate security measures to protect your personal data from unauthorized access, disclosure, alteration, or destruction. These measures include encryption, access controls, and regular security assessments.

You have the right to:
