## ■ **UF AND FIU NAMED AMONG TOP FIVE PUBLIC UNIVERSITIES IN THE COUNTRY**

The University of Florida and Florida International University are two of the top five public universities in the U.S., according to rankings released earlier this month by the [Wall Street Journal](#).

The University of Florida was named the number one public university in the country while Florida International University was ranked fourth. When factoring in private universities, UF finished 15th overall while FIU placed 29th. Florida State University ranked as the 35th best public university and No. 102 overall. The University of Miami, a private institution, ranked No. 90 overall on the list. Other Florida universities that made the list were: University of South Florida, University of Central Florida, Florida Atlantic University, Florida Institute of Technology and Florida Agricultural and Mechanical University.

The Wall Street Journal has published the best college rankings since 2016. The publication partnered with College Pulse and Statista to compile the rankings. This year, Princeton University claimed the top overall spot with Massachusetts Institute of Technology, Yale University, Stanford University, and Columbia University rounding out the top five.

The Journal improved its methodology in this year's rankings, "working with data scientists at [Statista](#), the new WSJ/College Pulse ranking uses the most recent available data to put colleges on a more level playing field, with a focus on comparing the outcomes of each school's graduates to what those students were likely to achieve no matter where they went to school," according to an article accompanying the rankings.

Not complying with the ADA could cost institutions millions of dollars in litigation fees and payouts.
