

## Victim Assistance Scheme (VAS)\*



Helping victims of serious crime by contributing to costs related to the crime, the justice process, and recovery.

\* Guide only. Funding may differ depending on individual circumstances.

Administered by Victim Support on behalf of the Ministry of Justice.

Sexual violence	\$500 lump sum to assist with the aftermath of a crime that has been reported to the Police.  A supplementary grant up to \$2,000 may also be available to assist with relocation, safety, and healing costs.	Counselling may be available if there are delays through ACC.	Grant available (with limits) for the victim and <b>up to 3</b> whānau/family and support people to attend trials, sentencing, hearings, and other justice sector proceedings.	\$124/day or \$62/half day for victim and up to 3 whānau/family, friends and/ or unpaid support people who have lost earnings.  \$300/day or \$150/half day for specialist agency support person when victim is giving evidence or reading Victim Impact Statement (if no unpaid supporter is available).	Up to \$2,000 may be available where a Police cordon has been put in place, the Police confirm they are investigating a crime and the victim has been displaced.
Serious crimes	<b>Up to \$2,000</b> to contribute to the safety and immediate financial needs for primary victims of serious crime.	<b>Up to 15 hours</b> are available for a primary victim of serious crime, for incidents after 1 July 2023.	Grant available (with limits) for the victim and <b>up to</b> 3 whānau/family and support people to attend trials, sentencing, hearings, and other justice sector proceedings.	\$124/day or \$62/half day for victim and up to 3 whānau/family, friends who have lost earnings and/or unpaid support people.	<b>Up to \$2,000</b> may be available where a Police cordon has been put in place, the police confirm they are investigating a crime and the victim has been displaced.

For the purposes of the grants, 'victim' is used to refer to the primary victim of a crime, i.e. the person against whom the crime was committed. Victim Support will determine whether you are eligible for the Victim Assistance Scheme based on criteria established by the Ministry of Justice.

Victim Support makes travel and accommodation bookings – funds are generally not given for reimbursement.
