We are Lattice, a US-headquartered company that provides people-focused performance management software as a service. You are receiving this Notice of Data Processing Activities ("Notice") as we have obtained your personal information from Cognism Limited (the "Third Party"). Lattice respects your privacy and wants you to be informed about how we collect, use, and process your personal information.

Purpose for Processing

Our Legal Basis

Categories of Recipients

International Data Transfers

Lattice Technologies Limited is an affiliate of Degree Inc. d/b/a Lattice, which is headquartered in the United States. These countries may have data protection laws that are different from the laws of your country.
