## Important information of BAERG MARTI (Liechtenstein) AG

## To note (important information regarding the purchase of material assets)

- The product presented in the meeting "Oak barrel with apple balsamic vinegar" is a merchandise and not a capital investment.
- The object of purchase is stored in a natural tunnel designated by BAERG MARTI (Liechtenstein) AG in the high mountains at an altitude of approx. 3,000 metres, protected from the weather and access by unauthorised persons, and subjected to regular quality controls. During storage, the object of purchase is insured against water, fire, and other natural hazards as well as against burglary and theft.
- Balsamico is a natural product. The individual nature of the natural tunnel and the climatic conditions at the
  place of storage lead to evaporation and to the formation of balsamic crystals over the time of storage.
   BAERG MARTI (Liechtenstein) AG gives no guarantee for quantities after the maturing period in the natural
  tunnel.
- When ordering old vintages, it is not possible to determine the exact amount of balsamic and balsamic crystals already formed. Oak barrels are purchased unopened without determining the actual quantity at the time of purchase.
- The object of purchase shall remain the property of BAERG MARTI (Liechtenstein) AG until the purchase price and all associated costs and expenses have been fully paid.
- The customer appears directly as the buyer of an exactly specified quantity and type, without considering the interests of other customers of BAERG MARTI (Liechtenstein) AG. The buyer of the material asset becomes the beneficial owner.
- An economic development cannot be predicted conclusively. In case of correspondingly negative development of the goods, total loss of the capital invested is possible. No guarantee is assumed for the achievement of the economic, fiscal, and other goals of the beneficial owner of the goods.
- There is no entitlement to interest and repayment, except in the case of an effective revocation of the contractual declaration (withdrawal from the contract). Furthermore, there is no pecuniary claim to cash compensation in exchange for the temporary transfer of money.
- If the supplier does not find a buyer e.g., after the expiry of the storage period, the owner shall himself/herself undertake the sale of his/her goods if he/she wants to or must sell his/her goods. For private individuals, it can be difficult to sell the material asset by themselves if necessary. Alternatively, he/she can take delivery of his/her property or have it stored further.
- Future decisions of the financial management, legislative changes, and changes in the administration of justice can decisively influence the fiscal treatment of a purchase of a material asset.
