

# PRIVACY STATEMENT

## **Purposes of processing**

Pecocar Holland B.V. processes your personal data for the purpose of: We collect and use our users' personal data only to the extent necessary to provide a functional website and our content and services. The collection and use of our users' personal data only takes place regularly with the user's consent. An exception applies in cases where it is not possible to obtain prior consent for factual reasons and the processing of the data is permitted by law.

## **Legal basis processing**

Pecocar Holland B.V. processes your personal data on the following legal basis:

The processing of your personal data is necessary to pursue the following legitimate interest(s) of Pecocar Holland B.V. or a third party:

Temporary storage of the IP address by the system is necessary to enable delivery of the website to the user's computer. For this purpose, the user's IP address must remain stored for the duration of the session. Each time our website is accessed, our system automatically collects data and information from the computer system of the accessing computer.

Among other things, the following data is regularly collected and stored:

- Referrer (previously visited website)
- The browser you are using and your operating system
- Requested website or file
- Operating system used
- Type of device used
- The circumstances of the visit (date & time)
- IP address in anonymised form (only used to determine the location of access)

## **Provision of personal data by data subject**

Disclosure of personal data by the data subject

The data subject is not obliged to provide certain personal data to Pecocar Holland B.V. There is a contact form on our website that can be used to contact us electronically. If a user makes use of this option, the data entered in the input mask will be transmitted to us and stored.

This data includes

- Your name and surname
- Your e-mail address
- Your telephone number (if provided)
- the message sent to us

In addition to this information, your IP address and other data collected for the purpose of providing the website will be stored.

No data is passed on to third parties in this context. The data is used exclusively for processing the conversation.

Your consent is obtained for the processing of the data as part of the contact enquiry by confirming your entry using the "Send" field.

#### **Categories and source(s) of personal data**

Pecocar Holland B.V. has obtained the following regular personal data (IP addresses, Internet providers, location data, email addresses, device data, names, phone numbers, LinkedIn accounts), from the following source(s): sales agreement, contact form and LinkedIn.

These are not public source(s).

#### **Recipients of personal data**

Pecocar Holland B.V. will not provide your personal data to third parties.

#### **Retention period personal data**

The data is deleted as soon as it is no longer required to fulfil the purpose for which it was collected. For the personal data from the input screen of the contact form and those sent by email, this is the case when the respective conversation with the user has ended. The conversation is ended when it can be inferred from the circumstances that the matter in question has been conclusively clarified.

#### **Data subjects' rights**

You have the right to submit a request to us to inspect, correct and/or delete the personal data we process about you. In addition, you have the right to request us to restrict the processing of your personal data and to object to the processing of your personal data.

As a data subject, you also have the right to request Pecocar Holland B.V. to retrieve the personal data you have provided yourself to Pecocar Holland B.V. in a structured, common and machine-readable form, so that you can provide this personal data to another controller if you wish.
