Greentiger AI, Inc Program Privacy Policy Effective Date: May 1, 2021

This policy describes how Greentiger AI, Inc (“Swadesh,” “we,” “us,” or “Greentiger AI, Inc.”) collects, aggregates, stores, safeguards and uses the data and information (including non-public personal information, or “NPI”) provided by users through our website, [www.swadesh.co] (the “Site”), as well as information collected by us through other means, including by email, over the phone, or in offline communications. This Site is operated by Greentiger AI, Inc and has been created to provide information about our Greentiger AI, Inc, products, and services (together, the “Services”).

We take your privacy and the security of your information seriously. This policy explains:

- What information we collect, and how we use it
- Choices you can make about the way your information is collected and used
- How we protect personal information electronically and physically

This policy is incorporated into and a material term of your registration and/or use of Greentiger AI, Inc’s products and services, including our website, www.swadesh.co. By using the Site or Services, you consent to the practices set forth in this Privacy Policy.

When the Privacy Policy mentions “Company,” “we,” “us,” or “our,” it refers to Swadesh, a Delaware C-corp corporation and Greentiger AI, Inc. you are

contracting with in this policy. Swadesh referred to herein as “Greentiger AI, Inc” unless the context requires otherwise.

INFORMATION WE COLLECT

Information You Provide to Us

Greentiger AI, Inc collects information from you when you choose to provide it to us through the Site or through any other means. This may include when you create an account on the Site, register or request products or services, request information from us, sign up for newsletters or our email lists, use our Site, or otherwise contact us.

The information we collect may include your name, address, email address, telephone or mobile phone number, information relating to your employment or professional activities and financial account information. You may be required to provide certain personal and/or business information to apply for and receive Greentiger AI, Inc products services.

Information We Automatically Collect

We may use cookies or other technologies to automatically collect certain information when you visit our Site or interact with our emails. For example, if you are responding to an offer, promotional email or other email from us, we may automatically populate your personal information into our system once you enter your offer code or similar identifying device or otherwise accept your offer or promotion. Additionally, we may automatically collect certain non-personal information from you such as your browser type, operating system, software version, and Internet Protocol ("IP") address. HOW WE USE INFORMATION WE COLLECT

Greentiger AI, Inc uses the data and information you provide in a manner that is consistent with this Privacy Policy and applicable law. If you provide personal data for a certain reason, we may use the personal data in connection with the reason for which it was provided. For instance, if you contact us by email, we will use the personal data you provide to answer your question or resolve your problem. Also, if you provide personal data in order to obtain access to the Site or Services, we will use your personal data to provide you with access to such services and to monitor your use of such services.

Greentiger AI, Inc, like many businesses, sometimes hires other companies to perform certain business-related functions. Examples of such functions include mailing information, maintaining databases, and processing payments. When we employ another entity to perform a function of this nature, we only provide them with the information that they need to perform their specific function. Business Transfers:

act in urgent circumstances to protect the personal safety of users of the Site, the Services or the public, or (iv) protect against legal liability.

BIOMETRIC DATA

We will collect and transfer your biometric data to third parties who shall process your biometric data only for KYC purposes. Such processing of your biometric data for KYC related processes is required for Greentiger AI, Inc. to render its services to you. The data

collected will be used solely for the stated purpose and will not be used for any other unrelated purpose without obtaining your explicit consent.

CHILDREN AND MINORS

Greentiger AI, Inc does not knowingly collect personal data from minors under the age of 18. If you are under the age of 18, please do not submit any personal data through the Services. We encourage parents and legal guardians to monitor their children's Internet usage and to help enforce our Privacy Policy by instructing their children never to provide personal data without their permission.
