Part 1 – Standard

1. Our Websites

1.1.1. The information on our Websites is provided by Podium and while we endeavour to keep the information up to date and correct, we make no representations or warranties of any kind, express or implied, about the completeness, accuracy, reliability, suitability or availability with respect to the Websites or related Products, Services or Partners contained on our Websites for any purpose. Any reliance you place on such information is therefore strictly at your own risk.

1.2. Permitted use

1.2.1. Our Websites are for your personal, non-commercial use only. They may only be accessed and used by a private individual or by a business to seek information directly for that individual or business. Access to and use of the Websites other than for your personal, non-commercial purposes is strictly prohibited.

1.2.2. You are not permitted to use our Websites:

2. Our Services

2.1. Permitted use

2.1.1. Our Services are for commercial use, unless stated otherwise in "Part 2". They may only be accessed by private individuals or by businesses who have "Service Agreements" in place with Podium ("Clients"). Access to and use of our Services outside of the terms set out in these Terms of Use and supplementary Service Agreements is strictly prohibited.

2.1.2. It may be of benefit to Clients for agreed third parties ("Permitted Users") to have certain access to Podium Services. To achieve this without the need for each third party to contract directly with Podium, you agree to the following:

2.1.2.1. The Client shall procure that each Permitted User complies with all relevant provisions of these Terms of Use and relevant Service Agreement

2.1.2.2. Pursuant to the Contracts (Rights of Third Parties) Act 1999, these Terms of Use and relevant Service Agreements shall be enforceable by each Permitted User (to the extent permitted by law) as if each Permitted User were a party to the Service Agreement

2.1.2.3. "Exclusions of our Liability" shall apply on an aggregate basis across all claims that may be brought by the Client and/or a Permitted User under or in connection with the relevant Service Agreement

2.1.2.4. Unless explicitly agreed otherwise in the Service Agreement, a Permitted User must always be a Client Group Company to have access to the Services as set out in these Terms of Use. If any Permitted User is no longer a Client Group Company, the rights of the relevant Permitted User will automatically terminate (without further notice and without liability to Podium) on the date it ceases to be a Client Group Company

3. Your responsibilities

3.2.2. If you are in any doubt as to whether any information is relevant or required to be disclosed or that something may be incorrect you should disclose it to your relevant provider before you apply for a Product.

3.2.3. Before you obtain any Product from a provider, you must check all of the Data the provider holds about you to ensure it is correct, complete, accurate and not misleading and that you have disclosed all relevant facts. It is your responsibility to identify and correct any mistakes or errors in the Data before you obtain any Product. Failure to do so could invalidate the Product.

3.2.4. If you create or supplied any usernames, passwords or equivalent when using the Websites or Services, they must be kept confidential by you and must not be shared with any third party. 7.1. Mortgage Decision in Principle

7.1.1. Our Decision in Principle Services match your Data to the criteria companies are looking for to see your chances of successfully obtaining a mortgage Product from the indicated lenders. Our Decision in Principle Services have been built in partnership with certain trusted Partners; for a full list of mortgage lender Partners, and the terms associated with those Partners, see “Mortgage lenders” in our Privacy Policy. If you submit your details when using our Decision in Principle Services, we may pass your information to those Partners for the purposed of them indicating your chances of successfully obtaining a mortgage Product from them.

7.2. Mortgage account number finder

7.2.1. Our mortgage account number finder Service helps you find you mortgage account number(s) from an active mortgage account with a specified lender. This Service has been built in partnership with a trusted service provider, Experian Limited. If you submit you details when using our mortgage account number finder Service, we will pass your information to Experian Limited, to enable them to retrieve your mortgage account number from your Experian credit file. They will use a quotation or “soft” credit search that won’t harm your credit and only you can see. For the terms associated with Experian Limited see “Service providers” in our Privacy Policy.

7.3. Mortgage payment holiday calculator

7.3.1. Our mortgage payment holiday helps you understand the increase in balance and subsequent increase in monthly payments for reducing monthly payments for an agreed period with your lender. The actual increases will depend on a number of factors, such as whether your lender calculates interest on a daily, monthly, or annual interest basis, and when which day of the month you make your monthly payments. Our calculator makes assumptions about these factors and should therefore results should only be used as guide. Any mortgage holiday must be agreed with your lender first.

7.4. Mortgage sourcing

7.4.1. Our mortgage sourcing service helps you search for mortgage product rates that are currently available on the market, filtered and tailored to your mortgage requirements and circumstances, such as mortgage term, mortgage amount, and loan to property value percentage (LTV). The rates shown are based on your mortgage requirements only and a full eligibility check should be carried out with the selected lender to ensure eligibility for a given product.
