IILC at KM is a 501(c)3 nonprofit organization that built and manages KM apartments since 1988. It is specifically designed for physically disabled mobility challenged individuals who are able to live independently and direct their own daily living needs.

The building design entails the creation of barrier-free and fully accessible living space for tenants in an aesthetically pleasing environment. Each unit has a fully equipped kitchen and full-size appliances. ADA washers and dryers are located on each apartment floor along with a trash room. The building features two elevators, automatic doors, front door call system to be buzzed and security cameras.

IILC partners with the Department of Human Services/Division of Rehabilitative Services to provide non-medical activities of daily living per the person's case plan.

IILC/KM is centrally located to nearby Arrowhead Park, Ogden Mall, restaurants, businesses, employment, doctor's offices, Edward Hospital and more.

This is an ideal wheelchair accessible neighborhood for individuals or families that offers the opportunity for each person to integrate into the Naperville community and DuPage County.

### Typical ADLs include

- Assist with Bathing
- Assist to/from the bathroom
- Assist with Dressing/Undressing
- Assist with maintenance and appearance of hair, drying, combing and styling hair
- Assist with shaving only with electric or safety razor
- Cooking and Meal Preparation
- Assist with Household Chores
- Laundry/Trash Services
- Medication Reminders
- Assistance with shopping & appointments outside the home
- Companion Care
- Organize belongings
- Assist with Money Management

IILC only accepts DRS hours paid through Aetna Insurance or the local DRS office
