I've had the privilege of serving for the past eight years as part of DMEA's nine-member Board of Directors, democratically elected by you, our members. When I began in 2015, I didn't truly understand the significance of cooperative governance. That changed quickly!


The Board of Directors is primarily responsible for setting DMEA's strategic direction, which includes discussing policies, evaluating opportunities, setting your energy rates, and addressing industry-scale issues the co-op may face.

Over the years, the board has made several key decisions to improve the lives of its members, from adopting advanced meters and infrastructure to developing local hydro generation along the South Canal. During my time on the board, two decisions stand out. In 2016, DMEA launched Elevate Internet, the Western Slope's first 100% fiber internet company. Today, 68% of our service territory has access to internet speeds up to 6 Gig. And in 2020, our focus on affordable and flexible energy led DMEA to secure a new power supply contract with Guzman Energy, increasing our renewable generation capacity and setting predetermined power costs through 2033.

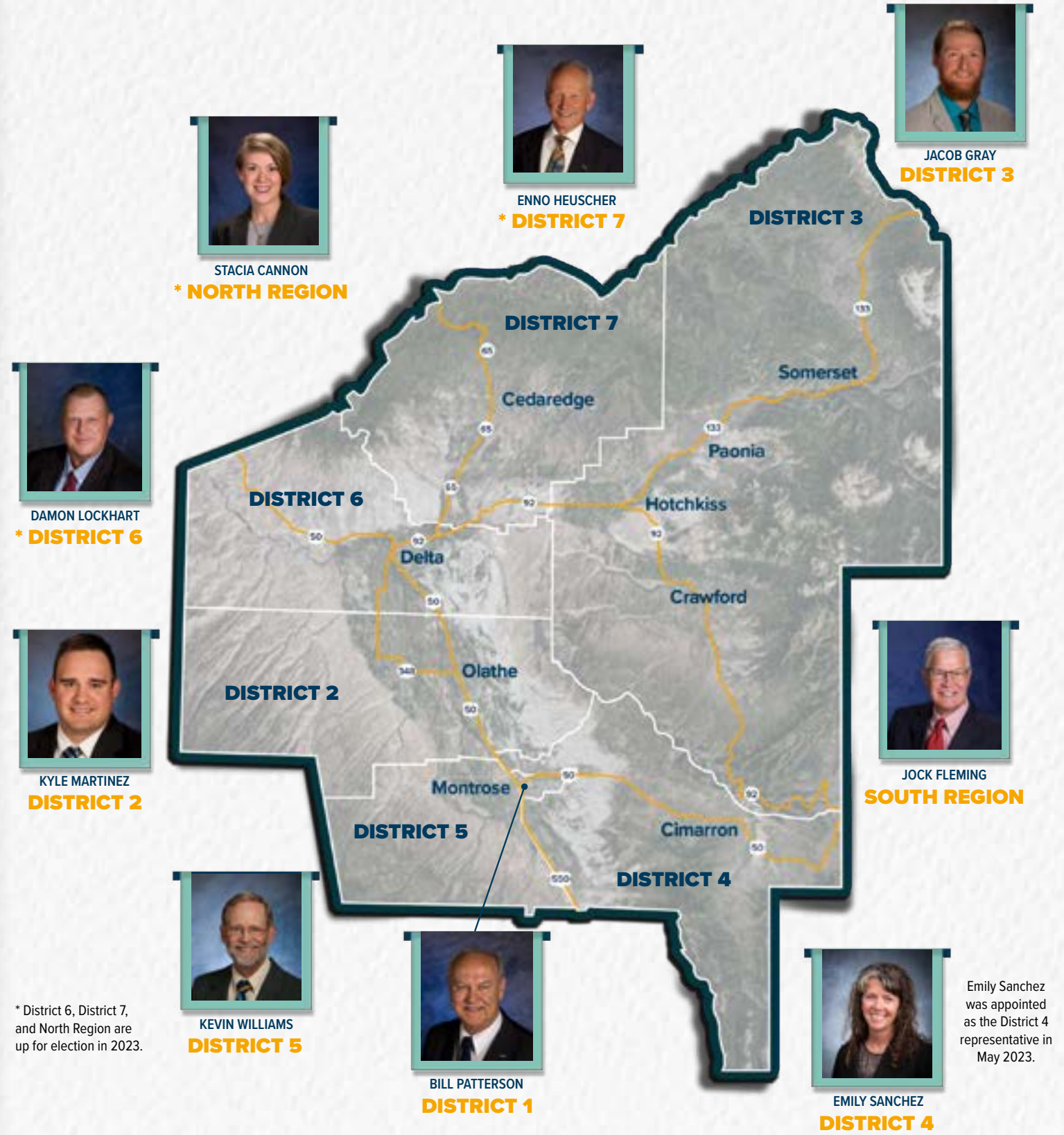
DMEA is fortunate to have a seasoned Chief Executive Officer who provides organizational leadership to ensure our vision is achieved and manages the day-to-day operations. He is supported by an executive team offering subject matter expertise and guidance, along with a talented team of employees who demonstrate a 24/7/365 commitment to our mission. 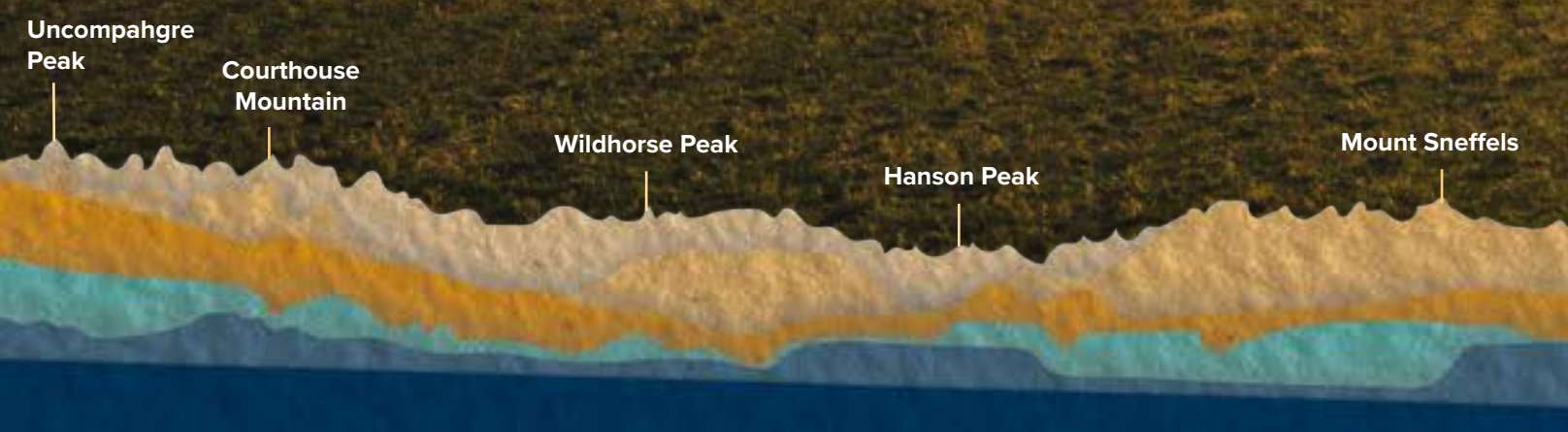

GARNET MESA SOLAR FARM

Agrivoltaics in Action

The 80-megawatt agrivoltaic solar generating farm is set to revolutionize energy production in Delta, CO, while boosting the local economy. A collaboration between Guzman Energy, Citra Power, and DMEA, this innovative project will span 383 acres and generate more than 194,000 megawatt hours (MWh) of electricity annually, enough to power 18,000 homes. The project is expected to create 350 to 400 construction jobs, primarily for local workers, in addition to new full-time positions in site management, sheep grazing, and farm management.

Agrivoltaics is a sustainable approach that combines solar energy production with active farmland use. The Garnet Mesa Solar Farm will incorporate sheep grazing, providing the animals with much-needed shade while they manage vegetation around the solar panels. Additionally, the solar panels help conserve water resources by reducing evaporation from direct sunlight on the ground. The Garnet Mesa Solar Farm represents a promising fusion of renewable energy and sustainable agriculture, serving as a model for future projects across the nation.

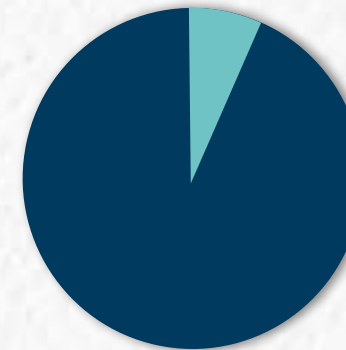

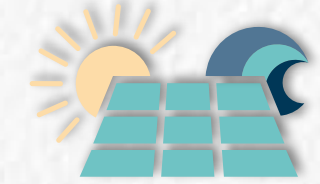

SOMERSET RELIABILITY PROJECT

Anthracite Creek Area Gets an Upgrade

In November 2022, DMEA completed a short but essential upgrade on the primary underground power line serving the Anthracite Creek area near Somerset. The 40+ year-old cable was vital to reliability in one of our most remote regions, bringing power to the homes, ranches, and recreation areas along County Road 12 towards Kebler Pass. But it had reached the end of its lifespan.

To improve reliability, particularly during the isolating winter months, and plan for future growth, DMEA replaced the aging cable with a new larger line. Underground work in the mountains is notoriously challenging, and the 3,500-foot project required DMEA to plow through rock to replace the line. Crews simultaneously installed additional conduit, which Elevate Internet will use in the future to build its fiber optic network.

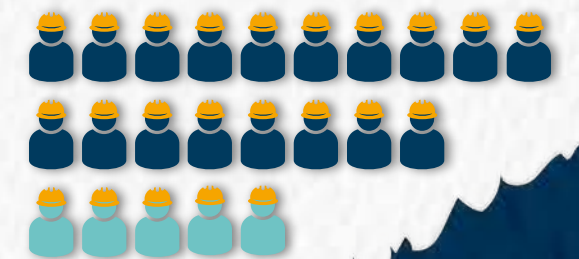

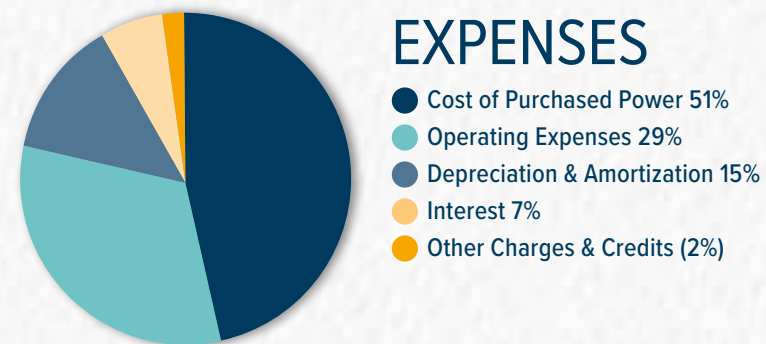
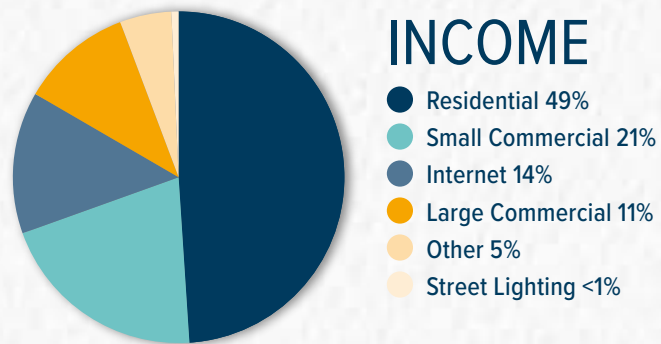

DOLPHIN HOUSE

At first glance, the unassuming bungalow on South First Street looks just like the other homes on the block. But looks are deceiving because out of this small home comes immense services. The Dolphin House Child Advocacy Center is a child-focused organization that supports child abuse victims and their non-offending family members.

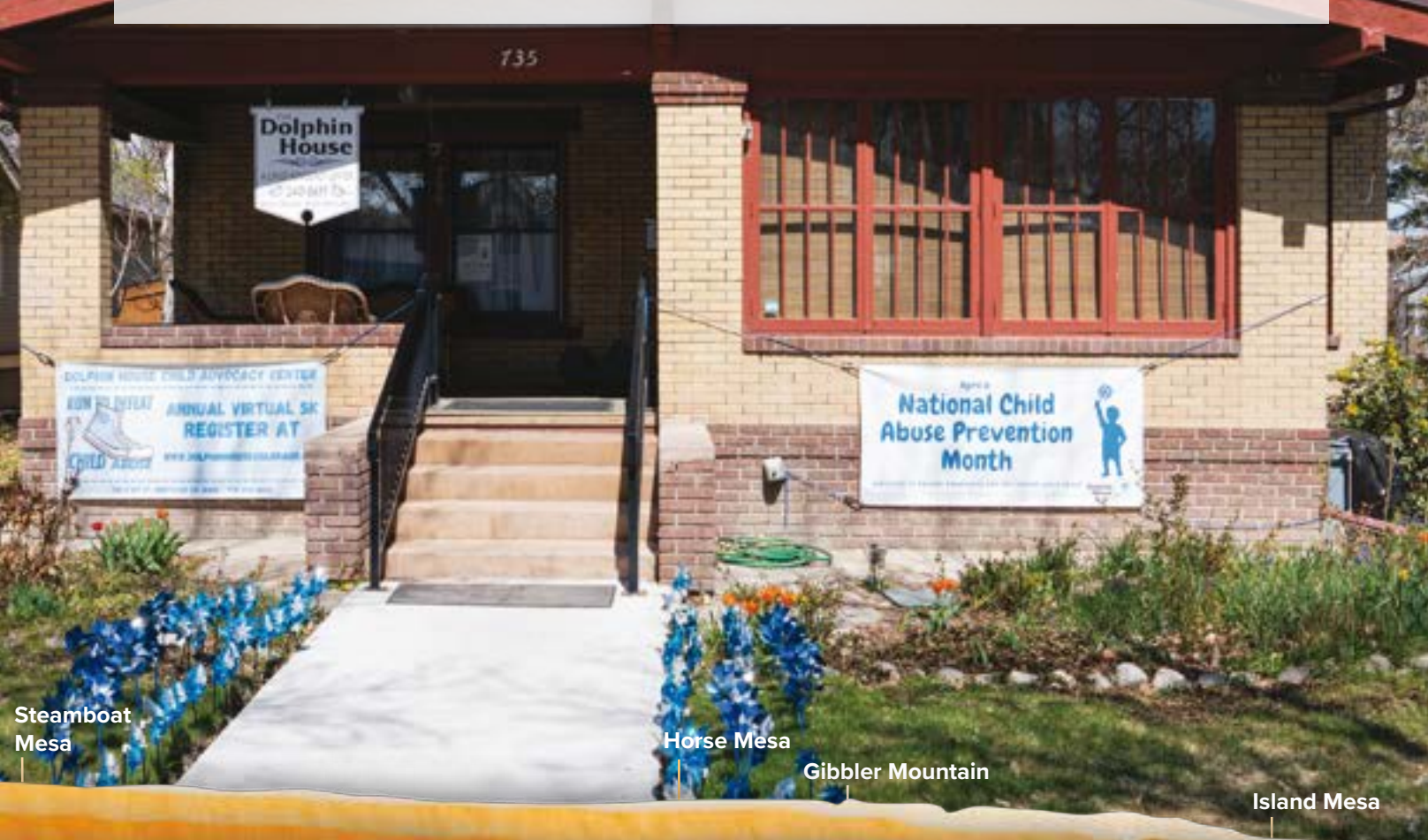
As an emergency-based organization, the Dolphin House is there for children through every step of an abuse investigation. Throughout the process, the team works to create a safe space for a child to tell their story. They also offer rigorous trauma and mental health support for non-offending family members.

Last year alone, the center supported more than 600 primary and secondary victims of child abuse all from its 100-year-old bungalow. Space, just like funding, is a challenge, and the agency will soon begin a capital campaign to expand and renovate the center.

With the need for mental health resources at a critical level in Montrose and Delta counties, DMEA chose to use a portion of its 2022 CoBank Sharing Success matching grant, donating \$6,666 to Dolphin House. Additional donations were also granted to CASA and Dream Catcher Therapy Center.

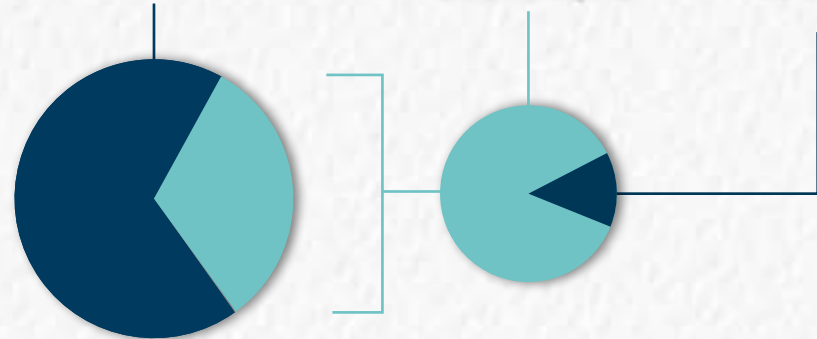

ELEVATE

6 GIG: THE BEST OF BOTH WORLDS

The Johnson family lives on a rural ranch near Paonia, Colorado. But despite their remote location, their work spans the globe thanks to their Elevate internet connection. Combining stunning surroundings and advanced technology, the Johnsons have found the perfect balance between modern connectivity and rural living. They became Elevate's first 6 Gig customer in November of 2022 because it allowed them the bandwidth to stream simultaneous video calls, host online courses, *and* transfer between 80 and 150 gigabytes worth of data every day.

Sam Krump-Johnson is an Animation Producer for Sledgehammer Games, which develops the Call of Duty series. He manages and stages large files between locations in multiple countries, downloading and uploading play test builds. His wife, Alex, develops and teaches online curriculum.

After the pandemic hit, Sam and Alex were ready to relocate from California's Bay Area to the family ranch in Paonia with Sam's father Theron. The availability of Elevate's fiber internet was the deciding factor. Theron was already using Elevate to maximize flexibility for his workforce at DIPCO, a manufacturing company.

"Personal liberty and freedom come with living in a place like Paonia," said Sam. "Having Elevate's 6 Gig fiber also plays into those values and opens the door to the digital space we need to do our work."

In the Bay Area, the Krump-Johnsons also purchased 1 Gig fiber internet service, but in reality, it maxed out at about 400 megabits per second.

"All my co-workers at Sledgehammer are so jealous of the internet speeds I get in this small town."

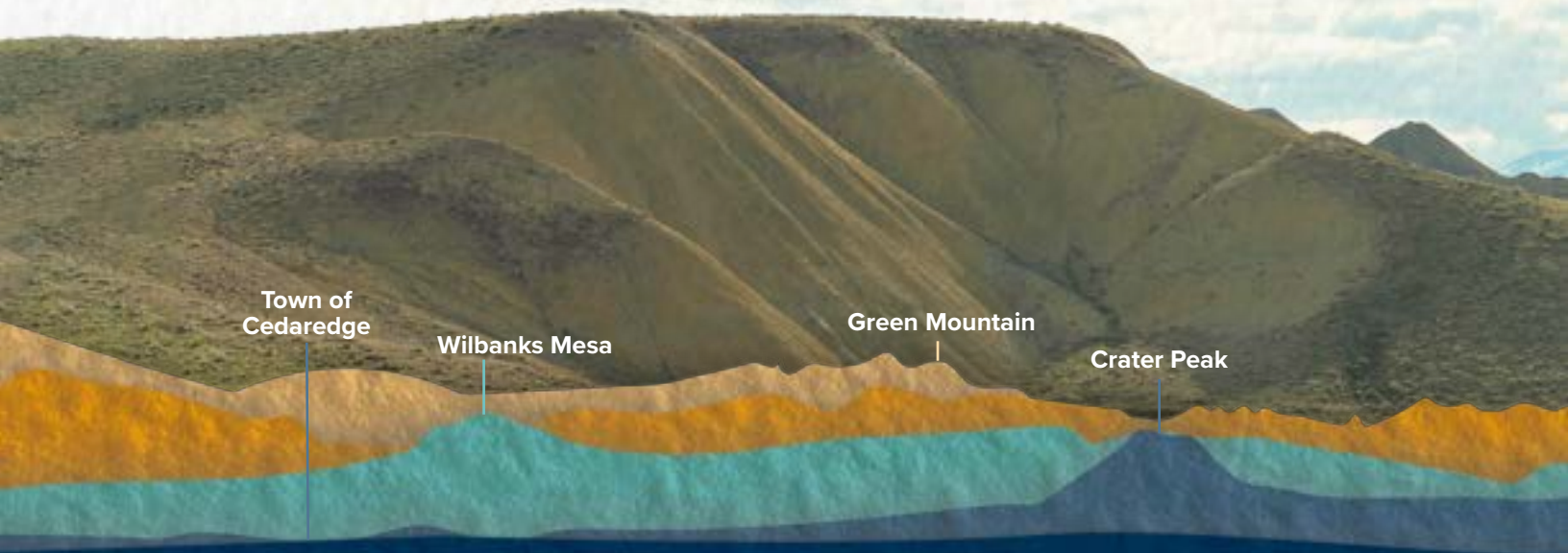
