
## Laua Outside Work

# SAFE & SECURE

Door sensors let you rest easy.

Door Sensors are an essential part of home security systems. If a door or window is opened when your system is armed, the alarm is triggered. Most smart systems issue a loud siren and send an alert to your smart phone too. So, whether it's an unwelcome visitor or your neighbor who forget to close up the back door when checking in on your home, you can rest easy.

- » To get started, count the number of doors and windows in your home - include the garage door, too
- » While reducing the number of sensors saves money, keep in mind that a single unsecured or unmonitored door could render your entire security system useless.
- » Your alarm panel often alerts you when your sensors aren't functioning properly, but it's wise to check regularly to prevent problems
- » Check your alarm panel regularly for error messages or warnings indicating a sensor problem. Notify your alarm company when this occurs so they're aware of your system problems and can help you with a solution.



Continue to hop away with your feet together as far as you can.

# Home COOKING

#### **Grilled Peaches With Vanilla** Ice Cream

Prep Time: 2 min. Cook Time: 4 min. Total Time: 6 min. Yield: Serves 8

Serving Size: 1/2 peach

#### Ingredients:

- 2 ripe peaches
- 2 ripe nectarines
- · canola oil
- 4 large scoops vanilla ice cream
- · Honey and sea salt for finishing

#### **Directions:**

Heat grill to medium high heat. Brush the peach halves with a touch of with oil and place on the grill for a few minutes, then rotate 90 degrees to continue to cook for about 3-4 minutes total grill marks appear and the fruit starts to caramelize. Remove from the grill with a pair of tongs and serve with a scoop of vanilla ice cream in the center of the fruit. Drizzle with honey and a sprinkle of flaky sea salt.
