In 2020, District #6, District #7, and the North Region board seats are up for election. Eligible members who live in these districts may become candidates. Friday, April 3: Nomination petition packets available.

Monday, May 4: Deadline to return nomination petition packets, including 15 member signatures and candidate profile information.

Monday, May 25: Ballots and candidate backgrounds mailed to DMEA members.

Friday, June 12: Postmark deadline for mail-in ballots.

Thursday, June 18: DMEA Annual Meeting. You may vote in person at the meeting if you did not vote by mail. The election concludes at the start of the business meeting and results are announced at the end of the meeting.

HOME COOKING



Overnight Caramel French Toast

Ingredients:

1 stick butter
1 cup brown sugar
1 Tbs maple syrup
1 loaf French bread
11/2 cups milk
6 eggs
1 tsp vanilla
1/8 tsp salt
1 cup pecans

Directions:

Melt butter in a 9x13 pan. Mix in brown sugar and syrup in the pan with a fork. Add pecans. Lay french toast slices on top. Mix milk, eggs, vanilla, and salt until well blended, pour over top. Refrigerate overnight. Bake at 350° for 50-60 minutes until custard is set and tops of bread are lightly browned. Flip over onto plate and serve. Sprinkle with powdered sugar if you like. Serves 6-8.

10 SAFETY PRECAUTIONS THAT CAN SAVE YOU \$5,000

Controlled burns are an important tool in Western Colorado for managing and restoring natural areas. Delta-Montrose Electric Association asks that you take extra precautions when burning near power poles to prevent widespread power outages and incurring up to a \$5,000 repair bill.

- **▶** Secure necessary permits
- ▶ Cut all grass and weeds near power poles
- ▶ Remove all dead trees within 20ft
- ▶ Water area near the power poles
- ▶ Plan to finish burns before noon
- ▶ Continuously monitor weather before and during
- ▶ Do NOT burn in high wind conditions
- ▶ Never leave burn unattended
- ► Have a plan to put out your burn
- ▶ Don't be afraid to call 911
