

How to go paperless in SmartHub


Say goodbye to clunky paper statements, save \$2 per month, and get your bill sent directly to your email.

Log in to your SmartHub account and select 'My Information' under the 'My Profile' tab.




On the 'My Information' page you'll see several account options listed. Select 'Update My Paperless Settings' on the

bottom of the list.





Simply click the slider to the right to set your account to paperless. The next step is to ensure you receive an email moving forward.

SHOCK TALK TREE PLANTING


Hey! What are you up to this weekend?
