While it might not have been my first cooperative annual meeting, it was my first annual meeting with DMEA and you, our members. It was a privilege to share some of DMEA's accomplishments in 2022 and highlight what's in store for the future.

I enjoyed interacting with all who joined us at Cedaredge High School last month for an evening of family fun. I hope the event also gave you a better understanding of how DMEA works to serve our communities.

2022 included numerous achievements for your cooperative. Number one on my list was that your electric rates have remained unchanged since the

latter part of 2019! And that trend will continue. **DMEA** has no planned rate increase this year or next!

During the meeting, we also concluded the annual Board of Directors election. Every year three seats are up for election as part of our 3-year rotation between DMEA's nine districts. Democratically-elected governance is one of the core principles of electric cooperatives that distinguishes them from investor-owned utilities. Please join me in thanking all our hardworking candidates and congratulating our winners.

For those who were unable to attend, we missed you and hope you can make it next year. A special thank you to members who turned out to support us and enjoyed DMEA's annual meeting. I hope to see you again next year – if not sooner!

# **2023 Annual Meeting Highlights**

254 attendees enjoyed local BBQ and pie, card games, live music, and a photo booth

Another year of stable rates and no planned rate increase through 2024

Election results: Damon Lockhart won District 6 with 2,242 votes (71.2%), defeating Mark Youngwirth with 909 votes (28.8%); Enno Heuscher ran unopposed in District 7 and was reelected; Stacia Cannon won the North Region with 2,343 votes (74%) defeating Paul Sweitzer with 822 votes (26%)

Elevate Internet offers future-proof internet, adding 2 Gig and 6 Gig to its speeds

Approximately 68% of DMEA's territory has access to Elevate's fiber network

Over the next three years, Elevate will expand to approximately 95% of DMEA's territory

DMEA celebrated a stellar safety record with 0 lost time injuries

Gerald Michael won DMEA's grand prize, a locally-made e-bike from Paonia-based Optibike





# Students Take Part in Global Competition

Destination Imagination is a global youth STEM competition that encourages students to develop solutions to complicated problems using creativity, engineering, teamwork, and time management skills.

Paonia's K-8 Inertia Team placed first during the regional competition, second at the state competition, and 13th in their division at the global finals, held May 20-23 in Kansas City, Missouri. The competition was truly global, with more than ten countries represented, allowing the Inertia team to participate on a world stage.

Students had the opportunity to understand problems, ask effective questions, present solutions, learn from failure, and celebrate their achievements. The participants learned vital life and career skills—creative and critical thinking, public speaking, and collaborative problem-solving—that set them up for future success.

DMEA's Operation Round Up helped foster huge student growth through Destination Imagination! I saw shy students find their voices, use feedback to determine adjustments that would have the most impact to their solution, and get celebrated for their unique skills.



# CONGRATS! YOU WON A CONTEST YOU DIDN'T ENTER

This scam often comes as a pop-up, email, or even phone call. Pop-ups that contain too-good-to-be-true prizes are just that — too-good-to-be-true. Instead, they are a ploy to capture your information for illegal use or install a virus on your device (computer, smartphone, laptop, tablet).

The same is true for emails and phone calls. Remember, if you didn't enter a contest, you probably didn't win it! And if the first step to winning a contest is to provide personal and financial information, you know it's not legit. Never pay money or give out sensitive information to claim a prize.

There are many legitimate giveaways and raffle programs offered by many legitimate businesses, Elevate included. Scammers may even try to use the names of businesses and organizations you know to trick you. No genuine company will ask you to pay money to claim your prize, and if you're still unsure, contact the company directly to speak with their staff. Be sure to look up the company's contact information on your own, and don't rely on what's included in the email, pop-up, or by the caller.

# Watch Out for **SOLAR SCAMS**

Members Beware: Don't fall for deceptive solar sales scams. Salespeople and ads are circulating claiming false information about pricing and rebates in association with DMEA. Watch out for:



## **PUSHY SALES**

Don't let anyone pressure you with deadlines or urgent messaging.



#### NAME DROPPING

Just because a salesperson says they are working with us, it isn't necessarily so.



## **TOO GOOD TO BE TRUE**

If something seems too-good-tobe-true, it probably is. Confirm rebates and tax credits with the state or U.S. Government.



#### SOCIAL MEDIA ADS

Don't click on the ad - verify information on ads by researching the company through a third party website.



#### **BEFORE YOU SIGN**

Call DMEA before you sign a solar contract to make sure we are able to accommodate you and your solar contractor.
