What does Colorado's BEAD Funding Mean for DMEA?

Recently, the news has been dominated by the topic of BEAD funding. There's a good reason for it too! So, this month, I'd like to provide a bit of history on the program and explain what it means for DMEA.

In November 2021, the Information Infrastructure and Jobs Act (IIJA) was signed into law and later became known as the Bipartisan Infrastructure Law (BIL). Hailed as a modern "New Deal" program, this law focuses on rebuilding or expanding our country's basic infrastructure, from transportation to drinking water to energy development.

One of the most essential components, though, is the *Internet for All* initiative that dedicates \$65 billion to the goal of bringing high-speed internet to every American home. Of this, \$42.5 billion is earmarked specifically to build and expand telecom networks, and is called Broadband Equity, Access, and Deployment funding, or BEAD for short. Recently, Colorado received its \$826,522,650 BEAD allocation. In July, our state officials announced that Colorado will distribute its allocation via the Colorado Broadband Office's Advance Colorado Broadband grant program. So, what does this mean for DMEA? It means we're one step closer to officially closing the digital divide!

State and federal grants have been crucial to our ability to build Elevate's fiber network in many rural areas. Over the years, we have secured almost \$56 million in grant funds, which has allowed us to bring high-speed internet to thousands of rural homes and ranches.

Once we complete all of our current grant projects, 95% of DMEA members will have access to Elevate's multigigabit internet. This new funding will help us continue closing the gap and move us that much closer to connecting **every** member.

The digital divide is two-fold, though. We recognize that having access to our high-speed internet doesn't automatically mean you have the financial ability to take advantage of it. Another critical aspect of the *Internet for All* initiative is the Affordable Connectivity Program (ACP). Congress dedicated \$14.2 billion (of the \$65 billion) to ACP alone. Established by the Federal Communications Commission in 2022, the ACP provides a significant discount on internet services for low-income households. This renewed investment in the ACP addresses the affordability gap by providing a \$30 monthly discount for eligible households.

Eligibility is very inclusive as the income level qualifier is double the traditional poverty level. It's estimated that roughly 40% of American households qualify for the ACP discount, yet rates are much lower. I'm proud to share that in 2022, Elevate took steps to add ACP to our offerings and better serve our consumers. We aren't immune to the national trend, and participation in Montrose and Delta counties has also been slow to take off. I encourage you to check your eligibility online at getinternet.gov.

High-speed internet is an essential utility in our modern life. Colorado's BEAD funding is critical in helping providers like us ensure that neither lack of infrastructure nor income prevents any Coloradan from having it.






CLEARING THE WAY

MANAGING VEGETATION FOR SAFETY, RELIABILITY, AND AFFORDABILITY

Trees keep us cool with shade, provide habitat for wildlife, and make our landscape beautiful. Unfortunately, trees that grow too close to or into DMEA's power lines can result in power outages and safety risks.

DMEA's vegetation management crews are responsible for trimming and removing trees along all our distribution and transmission lines. This is important for three reasons:



- Safety Electricity can travel through trees and injure or kill anyone working or playing on the tree. In addition, trees growing too close to power lines increase the risk of deadly wildfires.
- Reliability Maintaining proper clearance around lines significantly reduces the chance that adverse weather will send trees or limbs into our lines and equipment.
- Affordability Preventing the need to repair and replace our power lines, poles, and equipment because of tree damage helps deliver affordable electricity.


GIVE US SPACE

WE NEED ACCESS TO OUR PAD-MOUNTED TRANSFORMERS

Pad-mounted transformers are part of the underground electrical system in your neighborhood. They are placed on easements in yards and serve the same purposes as transformers on utility poles. Because they connect several homes, underground lines may radiate out from them in many directions.

- Maintain a 4-foot clearance around the back and sides of the transformer. Equipment inside the box generates heat and needs air circulation to keep cool and run efficiently. Overheating can cause an outage.
- Maintain a 10-foot clearance in front of the transformer. The equipment inside is energized at high voltage. Line crews need to access energized transformers to avoid interrupting your service. The linemen use long fiberglass insulated sticks and need 10 feet of clear space to work safely.
- Landscape with caution. While low ground cover won't restrict access, any plantings are at risk of getting trampled by crew members during maintenance and repair work.
