

## COOPERATION AGREEMENT

On the 6th of April 2023 in Lugano, a cooperation agreement was concluded between:

1. EmeraldsDAO consortium represented by Maciej Różak - the leader of the consortium, referred to in the contract as **the Brazilian Partner**,

and

2. DMGlobal AG Limited Corporation, headquartered in Switzerland at Chaltenbodenstrasse 16, 8834 Schindellegi, VAT number CHE307.178.238 and company registration number CH-130.3.019.283-5, represented by Michael Haerens - President, referred to in the contract as **the Swiss Partner**,

a cooperation agreement of the following content:

### § 1

The subject of this agreement is to define the terms of cooperation between the parties regarding the use of Cassette Di Sicurezza, including the office premises, located at Via Cantonale 1 in Lugano, Switzerland.

### § 2

In accordance with the agreements, at the time of submitting the registration application for the company in Switzerland at Via Cantonale 1 in Lugano, the Brazilian Partner will sublease a part of Cassette Di Sicurezza from the Swiss Partner for office purposes.

### § 3

The Brazilian Partner will receive from the Swiss Partner the possibility to use the common office space prepared for them by the Swiss Partner. The Brazilian Partner will receive their own keys to the shared space and will be able to use it according to their needs, informing the Swiss partner about their schedule month by month. However, Cassette can only be used after prior agreement and in the presence of the Swiss Partner.



**§ 4**

The Brazilian Partner undertakes to pay a deposit of 3 subsequent rents - 1500 CHF - to the Swiss Partner's account on the day of submitting the registration application for the company in Switzerland. The Brazilian Partner also undertakes to pay the Swiss Partner a monthly rent of 500 CHF by the 10th day of each month according to the rental invoice received from the Swiss Partner.

**§ 5**

The Brazilian Partner will use Cassette for depositing precious stones and gold mined from their Brazilian mines, which are intended for sale and commercialization in Europe.

**§ 6**


The Swiss Partner agrees to allow the official disclosure of information about the cooperation on the Brazilian Partner's website by publishing their logo with a link leading to their website, [www.dmglobal.io](http://www.dmglobal.io).

**§ 7**


If the terms of the agreement are not met, each party may terminate the agreement immediately. The Brazilian Partner anticipates a period of approximately 90 days to submit the registration documents for the company in Switzerland.

**§ 8**

The agreement has been made in two identical copies, one for each party.
