

PRIVACY POLICY

This website is operated by IMX Health, LLC. and its subsidiaries, including IMX Health, LLC, (collectively, "IMX Health"). At IMX Health we are committed to protecting the privacy of the persons who visit or use our website (the "Website"). By submitting any information about you to this Website, you consent to the use of such information as set forth in this Privacy Statement. Please therefore take the time to read the entire Privacy Statement carefully.

Collection of Information

In general, you can visit our Website without providing any personal information. However, you may be asked for personal information if you voluntarily register to receive additional information or services from IMX Health. Our voluntary Email Sign-Up form requests user personal information such as name, email address and company name. You can sign up to receive email notifications by submitting your email address and can unsubscribe at any time. We use a third party service provider for our email notification service and such service provider may not use, sell or otherwise share your personal information without our consent, which we do not provide to them.

Additionally, when you visit our Website, IMX Health may automatically collect information about your computer, including the IP address. See "Use of cookies and log files" below.

Uses of Information

We will use any personal information that is submitted by you to provide information and services to you for the purposes stated on the Website in accordance with this Privacy Statement.

This Privacy Statement applies, however, only to the information collected through the Website. It does not apply to the use of personal information collected through access to IMX Health's electronic trading platforms, whether provided through the Internet, electronically or by other means. IMX Health's trading platforms are only accessible to IMX HEALTH members and to any other participants of the IMX HEALTH exchanges

who have entered into definitive agreements with IMX HEALTH for such right of entry. Further, such definitive agreements' terms stipulate the rights of IMX HEALTH to use personal information collected by the IMX HEALTH exchanges from their members and participants and how such information will be collected and processed, not this Privacy Statement.

We may also anonymize your personal information and use it for other purposes, including for research and improvement of our Website or services.

Security

We exercise reasonable precautions to secure information provided to us by users of our Website. We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. Therefore, while we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security. We retain any information provided to us for the length of time that we have a user or other relationship with you and for such period of time thereafter as we are required to by governing regulatory authorities, including the United States Securities and Exchange Commission.

Access to and Disclosures of Information

Only IMX Health authorized employees and service providers have access to your information. Access is limited to the purposes of providing information or services you have requested from us, including to facilitate your interaction with the Website and IMX Health services and to identify you when you log into the Website to receive any services. We will not share your information with third parties other than with our service providers unless we are required to do so by law or as requested by a governing regulatory authority, or when we believe that disclosure is necessary to protect our rights, your rights, the rights of others as required by applicable law and to maintain the integrity of our business operations in accordance with our policies.

We will share information with regulators, government authorities, and third parties where we believe it is necessary to comply with a court order, subpoena, or regulatory request. We may disclose information when such disclosures will protect our rights or will assist in the enforcement of our Terms of Use or will protect your security. We also

may disclose information to support the detection of, prevention of, or response to fraud or intellectual property infringement.

As we grow as a company, we might become involved in transactions with third parties where we or they acquire or buy other businesses or assets. Also, we may participate in the negotiation or completion of a merger or sale involving all or a portion of IMX Health's operations or exchanges, or a corporate reorganization or stock sale or other change in corporate control. In such transactions, customer information generally is one of the shared or transferred business assets. We may share or transfer any information we have about you to a third party in such a transaction as an asset or for the purposes of such third parties carrying on our business in relation to the continued provision of our services to you as described in this Privacy Statement.

We may also share your information with our attorneys, banks, auditors, and advisors to answer a governmental inquiry or requirement and/or to accomplish a contemplated transaction.

Links to Third-Party Websites

Our Website may provide links to other third-party websites. Neither IMX Health nor its affiliated entities endorse any advice, goods or services offered by third parties. We have not verified the privacy policies applicable to third-party websites, nor have we determined what actions such parties will take regarding the privacy of visitors. In no event shall IMX Health or its affiliated entities be responsible for any third-party content, policies or actions. Except as required by applicable law, we will not provide any of your personal information to these third parties without your consent. We encourage you to read the privacy statements of other linked third-party websites when you leave our Website. This Privacy Statement applies only to information collected by our Website.

Use of Cookies and Log Files

When you visit our Website, IMX HEALTH may automatically collect information about your computer, including the IP address. IMX Health also may use cookies or other technology such as log files to gather anonymous information regarding usage of the Website to help IMX Health improve its Website content, usability, security and functionality, as well as to assist IMX in determining user-browsing patterns. This information may be combined with other information you provide to us. Visitors to the Website can set their browsers to (a) prompt before accepting a cookie; (b) accept

cookies automatically; or (c) reject all cookies. If you choose not to accept cookies from the Website, you may not be able to access and use all or part of the Website.

Google Analytics

We use a tool called “Google Analytics” to collect information about use of this site. Google Analytics collects information such as how often users visit this site, what pages they visit when they do so, and what other sites they used prior to coming to this site. We use the information we get from Google Analytics only to improve this site. Google Analytics collects only the IP address assigned to you on the date that you visit this site, rather than your name or other identifying information. We do not combine the information collected through the use of Google Analytics with personally identifiable information. Google’s ability to use and share information collected by Google Analytics about your visits to this site is restricted by the [Google Analytics Terms of Use](#) and the [Google Privacy Policy](#). Google has developed the Google Analytics opt-out browser add-on for the Google Analytics JavaScript (ga.js, analytics.js, dc.js).
