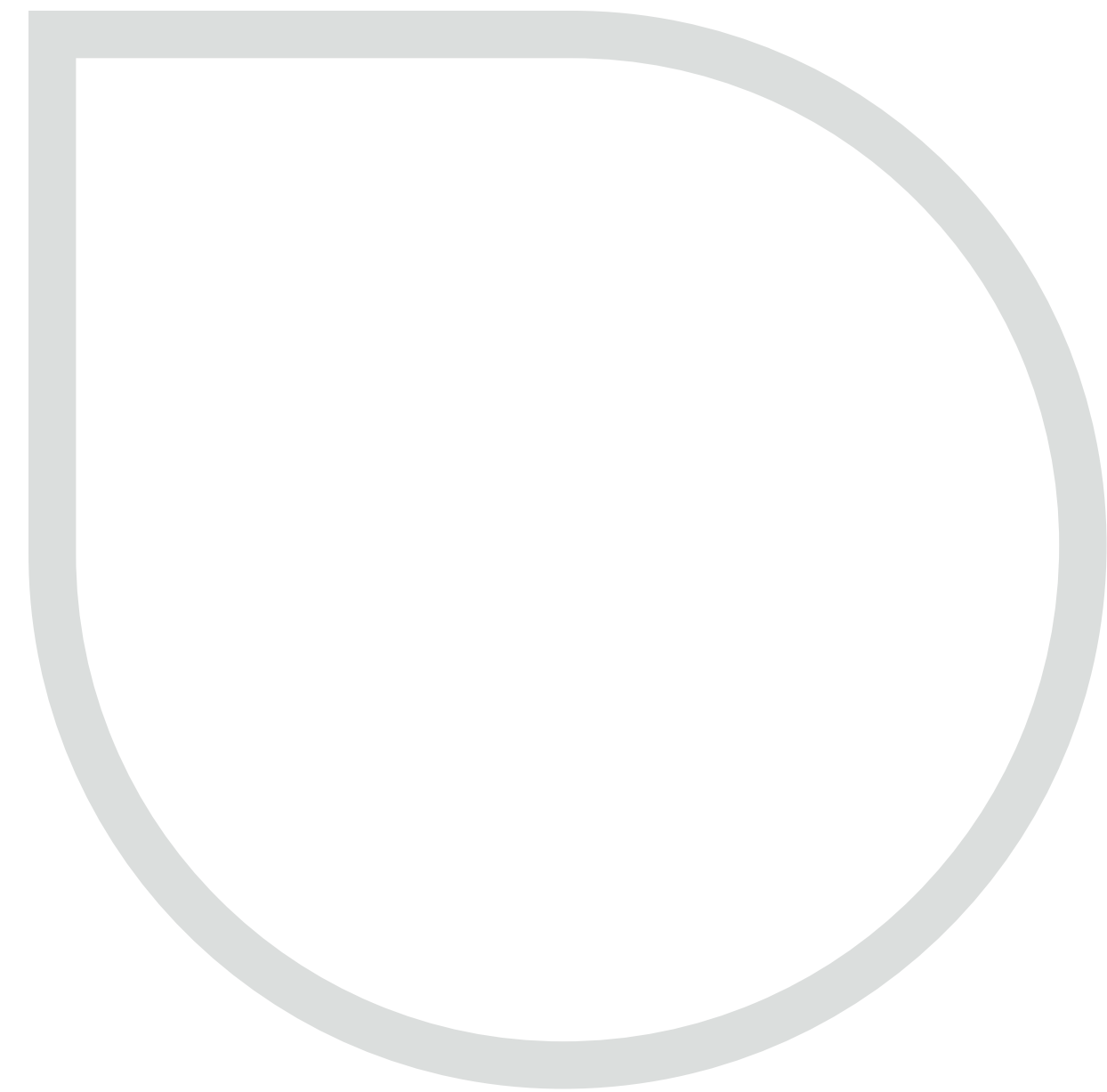
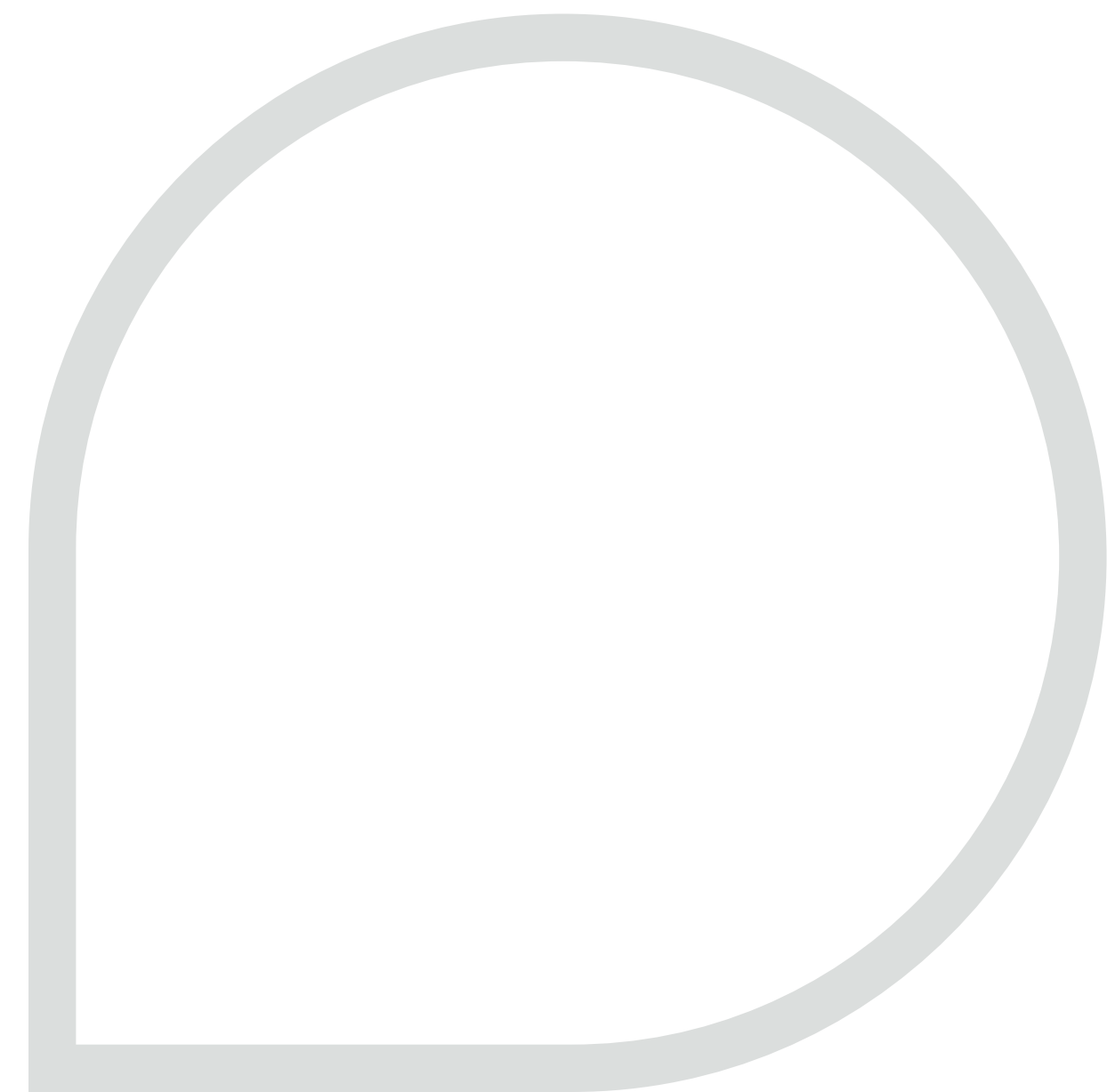

All the company's activities are highly organised in processes that guarantee total traceability and transparency of the material, from collection to processing and production.





RECOVERY

The recovery of textile waste is carried out by authorised vehicles from knitting, clothing, cutting AD weaving mills.

Textile waste undergoes an initial check to remove all non-fibrous material from the off-cuts.

The selection of materials follows a careful distinction by type and quality, with a classification by colour, fineness and composition.



CIRCULARITY

Green Line allows the various brands the possibility to buy the fibre obtained from the fraying previously carried out, in order to close the loop in the fashion sector.

Green Line will always be at the complete disposal of Brands that want to work together on new circular economy projects.



TRACEABILITY

Green Line allows full traceability of the material through the use of technology in order to monitor the process at each stage of recovery:

- Discharge of waste into the disposal area
- Selection by type and colour composition
- Shredding
- In-House fraying:
Process to create new regenerated fibre by processing the conferred offcuts.



SECURE DESTRUCTION OF LOGOED GARMENTS

Green Line avoids the risk of counterfeiting by providing an in-house service that guarantees mechanical shredding of the material delivered.

Thanks to this process, the material will be rendered unrecognizable and ready to be fed into the recovery process.

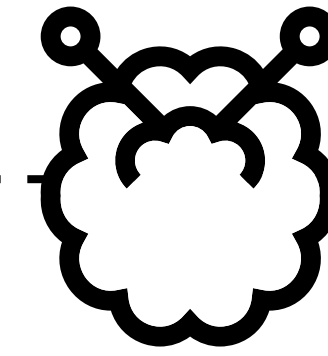

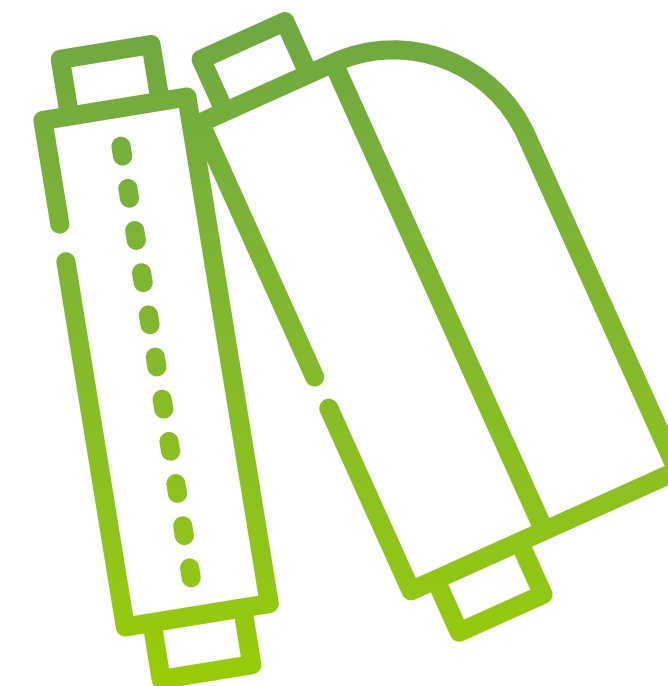
A smart and conscious service that gives new life to “deadstock” which are often unnecessarily stored.

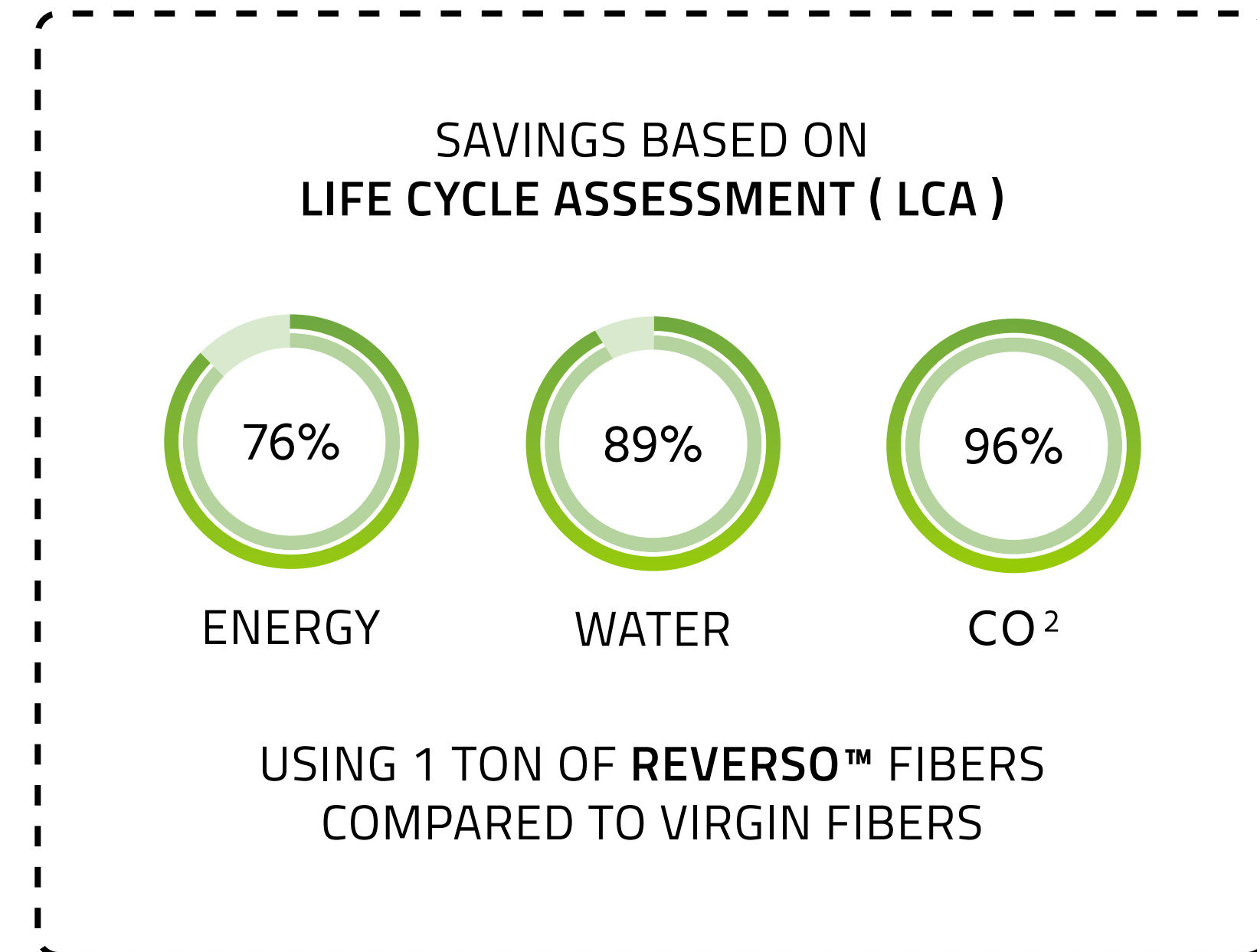

SAFE DESTRUCTION OF LOGOED GARMENTS

Green Line allows you to avoid the risk of counterfeiting through the provision of an internal service that guarantees the shredding of the material delivered. Thanks to this process, the material will be made unrecognizable and ready to be included in the recovery process.

GREEN LINE RECOVERY PROCESS

The collection of the material will be made with a vehicle authorized to transport textile waste. This activity can be managed by us internally or, if you prefer, through your suppliers who have authorized means.

The goods will travel with the Waste Identification Form (FIR)

If necessary, supervisory bodies such as the Guardia di Finanza, Agenzia delle Entrate, Notary or someone appointed by the Brand could be involved, who will take care of drafting their report to accompany our documentation. For this option, the use of vehicles equipped with seals to be affixed at the time of Loading is envisaged.

The safety of the storage in a dedicated and monitored area is guaranteed by a system of internal and external cameras, as well as by an alarm system connected to the Supervisory Center in charge.

The initial phase of the recovery process involves the selection by our operators of the material in order to guarantee the production of a raw material aimed at obtaining the best possible quality of the fiber resulting from the process.

The shredding of the material will be carried out by cutting by mechanical shredding to make everything unrecognizable and non-reusable. The entire process is made fully traceable thanks to our barcode labeling tools that allow the monitoring of the material in each of its stages.

Once the process is complete, Green Line will release all the documentation relating to the completed destruction.

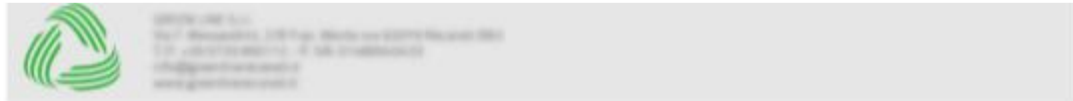
You will therefore receive:
