

Privacy policy

1. Introduction

This Privacy Policy regulates the collection, storage and processing of personal data related to the business of PBGW3 d.o.o. and the operation of the website <https://www.playbrandgames.com/>.

Personal data is processed in accordance with Regulation (EU) 2016/697 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (the "General Data Protection Regulation"), applicable Slovenian legislation on the protection of personal data and other legislation that provides us with a legal basis for processing of your personal data.

This Privacy Policy is provided in order to inform you about the basis and purposes of the processing of personal data by PBGW3 d.o.o. and the content and your rights in this area, in accordance with the requirements of the General Data Protection Regulation, as well as with the information regarding cookies when using the website <https://www.playbrandgames.com/>, which is managed by PBGW3 d.o.o.

2. Who is the controller of your personal data, who are the recipients and other information regarding contractual processing

Controller of personal data is company PBGW3 d.o.o., Rosinova ulica 22, 2000 Maribor (hereinafter: PBG).

PBG, as the controller of personal data, obtains personal data from individuals in the following ways:

- from individuals who have filled out a contact form on [●];
- directly from individuals who have provided PBG with contact personal data in the context of a business relationship;
- from individuals visiting the <https://www.playbrandgames.com/> website (cookies).

Recipients of personal data are employees of PBG and potential contractual partners of PBG as processors, who are obliged to respect and protect the personal data of individuals on the basis of the employment law regulation and a processing of personal data agreement pursuant to the General Data Protection Regulation.

3. The protection of personal data

1. On what legal basis do we process personal data?

a) Processing on a lawful basis

PBG processes personal data on the basis of the applicable regulations governing the protection of personal data, which provide an appropriate legal basis for the processing of personal data.

b) Processing of personal data based on the consent of the data subject

PBG processes the data for which you have given your consent for the purposes specified in the consent.

The conclusion of a contract with PBG is not conditional upon the consent. Giving consent is voluntary and if you decide not to give the consent or subsequently withdraw it, this shall in no way diminish your rights arising from your business relationship with PBG.

c) Processing of personal data on a contractual basis

The processing of personal data is necessary for the performance of a contract to which data subject is a party, to whom the personal data relate or to take action at the request of such neutral person before entering into a contract.

d) Processing based on legitimate interest

PBG may process personal data on the basis of legitimate interest, but only if, after a careful assessment, the interests of the company are not overridden by the interests or fundamental rights and freedoms of the data subject.

2. How do you withdraw your consent?

Consent is given only for the purposes specified in the consent and is valid until the consent is withdrawn. If you withdraw your consent in whole or in part, PBG will no longer use your data for the purposes for which you have withdrawn your consent.

If you wish to withdraw your consent, you may do so by sending a request to info@playbrandgames.com. PBG will record your request for withdrawal and, if possible, enforce the withdrawal immediately, or, if this is not possible, within 14 days of receipt of the withdrawal of consent.

3. What data do we collect and for what purposes do we process it?

By filling in the form on the website <https://www.playbrandgames.com/> you provide PBG with the following personal data: first name, last name, company, telephone, e-mail address. We need this contact information to process your message and to communicate with you.

All data and information collected is processed by PBG for the purpose of responding to your enquiry.

4. Information on transfers of personal data to a third country or an international organisation

PBG, as the controller, does not transfer your personal data to any third countries (outside the member states of the European Economic Area – i.e. EU member states and Iceland, Norway and Liechtenstein) and to any international organisations.

5. How long do we keep your data?

The period of retention of personal data depends on the basis of the processing and the purpose of the processing of each category of personal data. We keep personal data only for as long as is necessary to achieve the purpose for which the personal data were collected or further processed.

The personal data that you provided to us when sending the contact form on the website <https://www.playbrandgames.com/> are kept until withdrawal, or in accordance with applicable law. All other personal data within the framework of contractual cooperation are kept in accordance with the applicable legislation (the deadline from the contractual relationship is the statute of limitations according to the Code of Obligations).

6. Transmission of personal data to third parties

Your personal data will not be disclosed by transmission to third parties (except to contract processors).

7. The rights of the data subject

PBG guarantees you the exercise of your rights regarding the processing of your personal data without undue delay and in any case within 14 days of receipt of the request, unless the regulations set out a shorter period.

PBG accepts all requests concerning your rights regarding the processing of your personal data at the following addresses:

If there is reasonable doubt as to the identity of the data subject making the request in relation to any of his or her rights, PBG may request the provision of additional information necessary to establish or confirm the identity of the data subject.

You have the following rights under the General Data Protection Regulation:

- **The right of access to personal data**
If you wish to obtain information about the personal data held about you by PBG, you have the right to request the following information from PBG:
 - the purpose of the processing,
 - the recipients of the personal data,
 - the envisaged period of retention of the personal data or, if this is not possible, the criteria to be used to determine that period,
 - where the processing of personal data is based on the personal consent of the data subject, the existence of a right to withdraw consent at any time,
 - in the event that the personal data have not been collected from the data subject, all available information concerning their source,
 - the right to lodge a complaint with the Information Commissioner,
 - the existence of the right to request access from PBG,
 - the rectification or erasure of personal data or the restriction of the processing of personal data concerning the data subject, the existence of a right to object to such processing,
 - the existence of a right to data portability.

- **Right to rectification:**

You have the right to obtain from PBG without undue delay the rectification of inaccurate or incorrect personal data concerning you. You have the right to have incomplete personal data completed, including by means of providing a supplementary statement.

- **Right to erasure:**

You have the right to have your personal data erased by PBG without undue delay, and PBG is obliged to erase your personal data without undue delay where one of the following grounds applies:

- the personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed,
- the data subject withdraws consent on which the processing is based and where there is no other legal ground for the processing,
- the data subject objects to the processing and there are no overriding legitimate grounds for the processing,
- the personal data have been unlawfully processed,
- if the law so provides.

- **Right to restriction of processing:**

You have the right to obtain from PBG restriction of processing where one of the following applies:

- the data subject contests the accuracy of the data for a period which allows PBG to verify the accuracy of the personal data,
- the processing is unlawful and the data subject opposes the erasure of the personal data and requests the restriction of their use instead,
- PBG no longer needs the personal data for the purposes of the processing, but they are required by the data subject for the establishment, exercise or defence of legal claims,
- the data subject has objected to processing pursuant, pending the verification whether the legitimate grounds of the controller override those of the data subject.

- **Right to data portability:**

You have the right to receive the personal data concerning you that you have provided to PBG in a structured and readable form and you have a right, if it is technically feasible, to have that data transmitted by PBG to another controller where the processing is based on written consent and where the processing is carried out by automated means.

- **Right to object:**

As a data subject whose processing is necessary for legitimate interests, you have the right to object to such processing. In this case, PBG shall no longer process the personal data unless we can demonstrate compelling reasons for the processing which override the interests of the data subject. As a data subject whose personal data is processed for direct marketing purposes, you have the right to object to such processing, in which case PBG shall no longer use the personal data for such purposes.

- **Right to lodge a complaint with a supervisory authority.**

If you consider that you have not received an adequate response from PBG when exercising your rights, you have the right to lodge a complaint with the Information Commissioner (address: Dunajska 22, 1000 Ljubljana, email address: gp.ip@ip-rs.si, telephone number: 01 230 97 30, website: www.ip-rs.si).

- **Cookies**

The Company's website works with the help of cookies. A cookie is a text file that stores the settings of web pages. Cookies are stored by websites on users' accessing devices in order to identify individual devices and the settings used by users when accessing them. Cookies allow websites to recognise if a user has already visited a website. In the case of advanced applications, cookies can be used to adjust individual website settings accordingly. Their storage is under the full control of the web browser used by the individual - which can restrict or completely disable the storage of cookies if desired.

Cookies are essential for the provision of personalised online services. They are used to store information about the status of an individual website, to help gather statistics about users and website traffic, etc. We use cookies to evaluate the effectiveness of our website design.



Cookies stored by the browser can be deleted by the individual, instructions on how to delete them can be found on the web pages of the browser used by the individual.

The controller PBG does not disclose personal data collected through cookies to third parties.

Detailed instructions:

The storage of "cookies" can be disabled, deleted or switched off by the user by changing the settings in the browser. Disabling "cookies" may result in incorrect display of the website or parts of the content, for which PBG is not responsible.

The data generated by cookies may be used by the data controller, separately or in combination with the personal data provided by the individual, for the purpose of evaluating the use of the website, for the purpose of compiling reports on website activity, for the purpose of statistical data analysis, for the purpose of providing further services related to the use of the website.
